Marina: Brown Trout Tournament was successful. Dredging has been completed. Harbor Master R Oldenberg has done soundings and is satisfied with depths on interior and channel. Most docks have been installed. Remainder will be installed next week. Staffing is complete for Summer season.

Reminder to all that the Rowleys Bay boat launch, owned by the WI DNR, is temporarily closed for repairs. The Bues Point launch is open, but parking is very limited. Those parked outside of marked parking are subject to ticketing.

Town Hall: Work continues on Geothermal installation. All wells have been drilled and piping between the wells is being installed. Trenches should be filled and sod installation on the front lawn should begin next week. System should be complete by early to mid June.
