8. GENERAL BUSINESS

A. First reading of the Lakefront Sign Ordinance

- Juriga raised concerns about the use of Shall; Keeder reviewed the recommendation for use of reflective numerals but there is flexibility in color scheme; Officer N. Brooks discussed the importance of standard address signs for front of property and the lakefront is no different; Kissel clarified that there is no need for lighted lakefront signs since the reflection material is adequate, stressed that this is emergency-

response related even if not initially enforced, this information has been shared with VBT and matches their basic language; Martin, as a first responder, stressed the need for adequate signage even if the lake itself is not the City's

- Set Public Hearing: public hearing set for July 9 to be followed with second reading and approval to move to Council
- B. Sign Ordinance review – through the open discussion, Chair Courage thought it best to have a shared file made available to the Commissioners for review and notes; heard from Officer N. Brooks about outdated language that would leave the City open for litigation; commissioners would like to see more pictures of signs added for clarity; first reading will likely be August 2026
