

**MINUTES OF THE PUBLIC HEARING ON THE PROPOSED BUDGET
AND SPECIAL VILLAGE BOARD MEETING, NOVEMBER 25, 2024**

The public hearing on the Village of Biron proposed 2025 budget was called to order by President Jon Evenson on November 25 at 6:05 p.m. The proposed budget was properly published and posted as required by State Statutes.

PRESENT: Jon Evenson, Patty Gapen, Jamie Biegel, Mike Guillemot, Mark Honkomp, Dan Muleski, Tammy Steward

PROPOSED BUDGET: The proposed budget for 2025 was presented and reviewed.
Expenses: General Government \$346,921; Public Safety \$340,321; Public Works \$533,310; Health & Human Services \$1,750; Culture, Recreation & Education \$61,400; Conservation & Development \$1,150; Debt Service \$80,506; Miscellaneous Expenses \$1,150; for total expenses of \$1,366,508.00.

Revenues: Property Tax Levy \$877,078; Other Taxes \$120,198; Intergovernmental Revenues \$291,947; Licenses & Permits \$15,785; Miscellaneous Revenue \$36,500; for total revenue of \$1,366,508.00.

DISCUSSION: After discussion, no revisions were made to the proposed budget for 2025.

ADJOURN PUBLIC HEARING: Motion Muleski, second Gapen to close the public hearing at 6:20 p.m. Motion carried.

SPECIAL BOARD MEETING

The special meeting of the Village Board of Trustees was called to order by President Jon Evenson immediately following adjournment of the public hearing. The special board meeting was properly published and posted as required by State Statutes.

APPROVE CARRY FORWARD RESOLUTION 24-05: Motion Gapen, Second Biegel to approve resolution 24-05 that approves claiming the full allowable increase from the previous years unused levy capacity of \$12,671. Motion carried.

ADOPT LEVY: Motion Honkomp, second Steward to adopt the 2024 tax levy of \$877,078. Motion carried.

ADOPT BUDGET: Motion Steward, second Guillemot to adopt the 2025 budget of \$1,366,508.00. Motion carried

FLOODPLAIN LAND USE PERMIT: Motion Muleski Second Steward to approve the land use permit as submitted. Honkomp opposed. Motion carried.

ROLL CALL VOTE FOR CHARTER ORDINANCE 24-06: Biegel AYE, Evenson AYE, Gapen AYE, Guillemot AYE, Honkomp AYE, Muleski AYE, Steward AYE to combine Clerk and Treasurer position and make the new Clerk/Treasurer and appointed position. Motion carried.

Ordinance will be published as a Class 1 notice and will take effect after the current term ends.

ADJOURN: Motion Honkomp, second Gopen to adjourn the November 25, 2024 Special Board Meeting at 6:35 p.m. Motion carried.
