1. **Call to Order/Roll Call:** Cambridge: Trustees Blackwood and Crist. Trustee Franklin absent. Deerfield: Trustees Wilkinson and Hewitt. Trustee Dunnington absent. Others present: Tammy Jordan, Treasurer/Deputy Clerk/Deputy Administrator, Village of Cambridge; Cambridge President McNally; Deputy Laurtsen.
2. **Approval of Agenda:** *Trustee Hewitt made a motion to approve the agenda as presented, seconded by Trustee Blackwood. Motion carried.*
3. **Approval of Minutes:** *July 9, 2024: Trustee Blackwood made a motion to approve the minutes as presented, seconded by Trustee Crist. Motion carried.*
4. **Public Comment:** None
5. **Reports**
 - a. **Police: July, August 2024:** Deputies are dealing with some of the same people in both communities; stemming from the overdose death a couple of months ago. July had 220 calls and August had 153 calls. Nothing significant is happening in either Village. Cops-n-Bobbers was held, Fire Fest went well, Chili Fest in Deerfield is coming up. Deerfield Homecoming Parade is October 11, 2024; Deputy Laurtsen has submitted the road permit to the State. The department is down to two deputies; Deputy Boyce is on Paternity leave.

Trustee Wilkinson made a motion to approve the Police Report, seconded by Trustee Blackwood. Motion carried.

b. Court: July, August 2024:

Trustee Wilkinson made a motion to approve the Police Report, seconded by Trustee Blackwood. Motion carried.

7. New Business, Discussion and Possible Action:

a. Budget

1. **Dane County Sheriff:** Schedule A shows anticipated increases in health insurance at 11% for HMO policies, 23% for Point of Service Policies, dental insurance is increasing by 4%. Retirement contributions will increase to 15.9%. The deputy's union is in negotiations with the county and are requesting another pay increase; not included in Schedule A due to the uncertainty. For 2025, the annual estimated cost is \$709,053.36. In 2024 it was 686,803.87. An increase of \$22,249.49 to be divided between both Villages and the Cambridge School District.

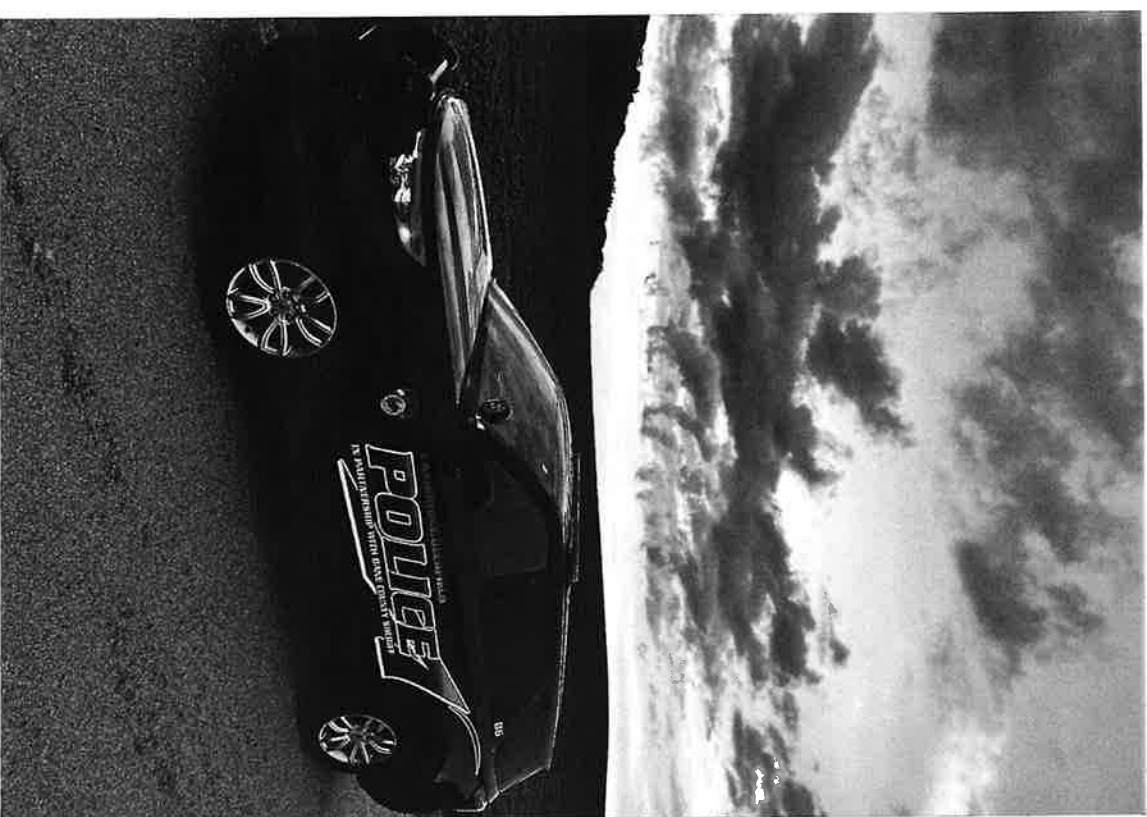
Trustee Blackwood made a motion to recommend the Police Budget to the respective boards, seconded by Trustee Crist. Motion carried.

2. **Court:** The Court Budget presented went from \$20,620.00 in 2024 to \$20,725.00 this year. It does not include a wage increase for staff – should be commensurate with Village Staff. Also, additional expenses should be considered in the Municipal Court Office to update laminate on front counter, and repair/replace broken hinges on cabinet doors.

Trustee Blackwood made a motion to recommend the Court Budget to the respective boards, seconded by Trustee Crist. Motion carried.

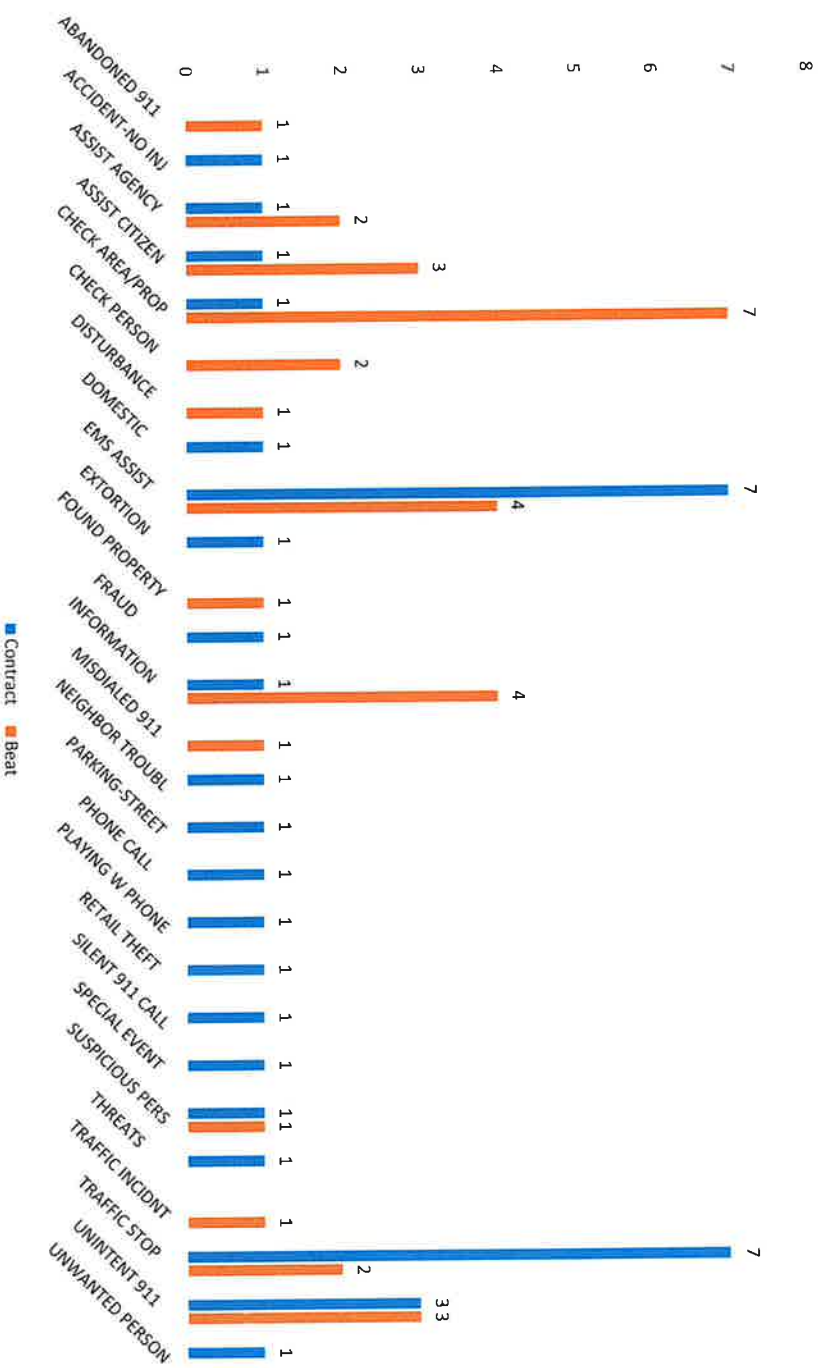

Cambridge-September 2024, Call Report Chart



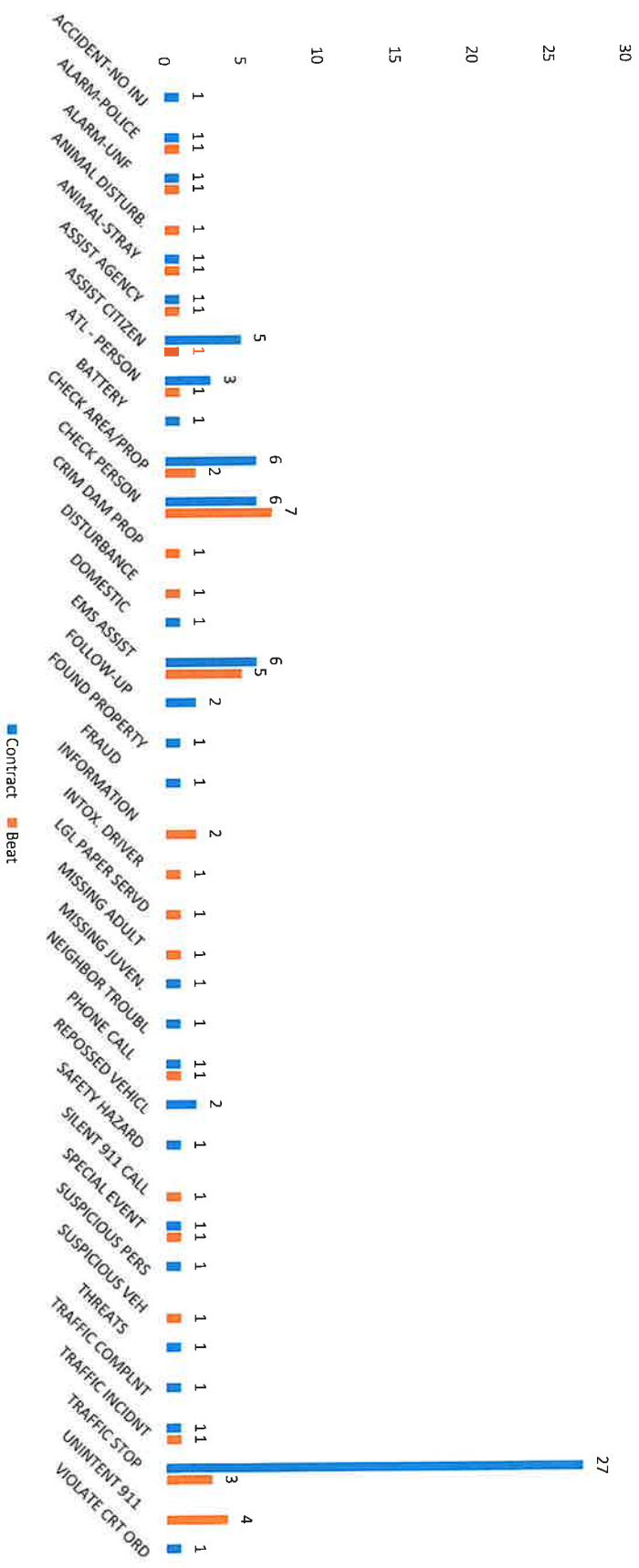

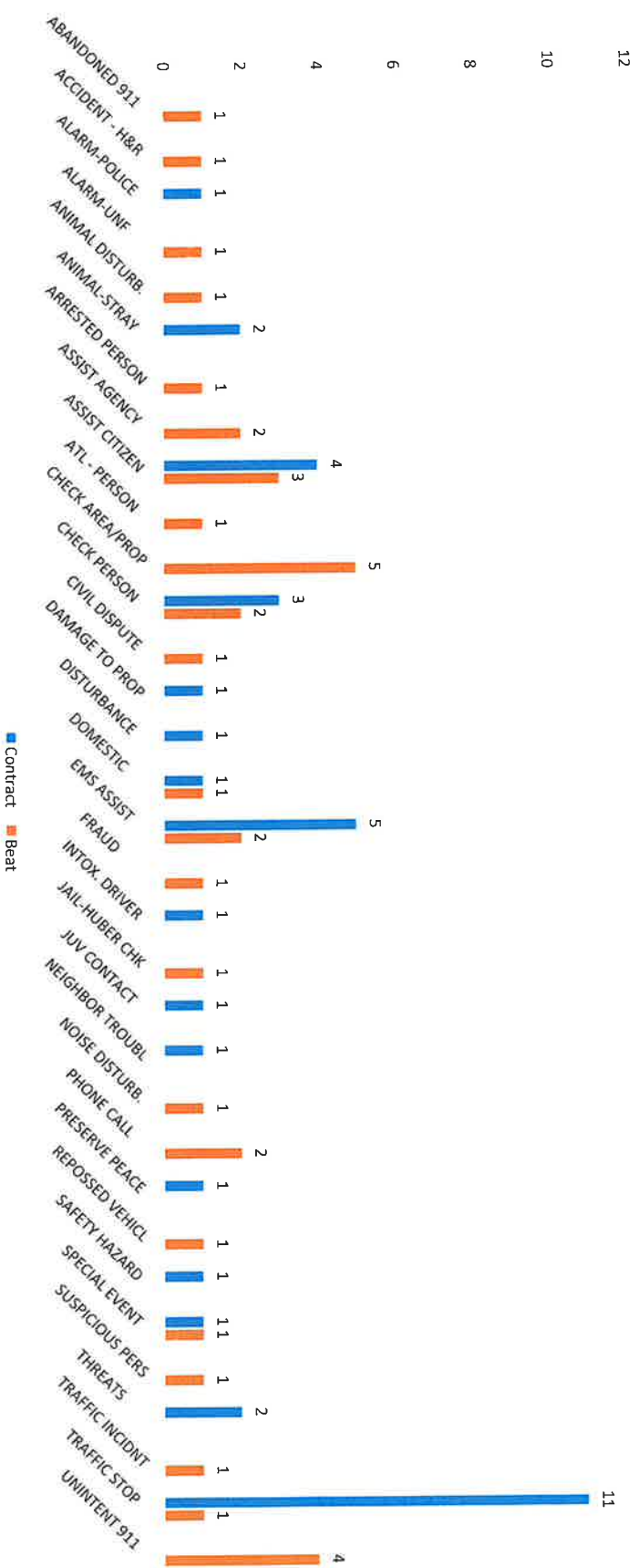

Deerfield-September 2024, Call Report Chart



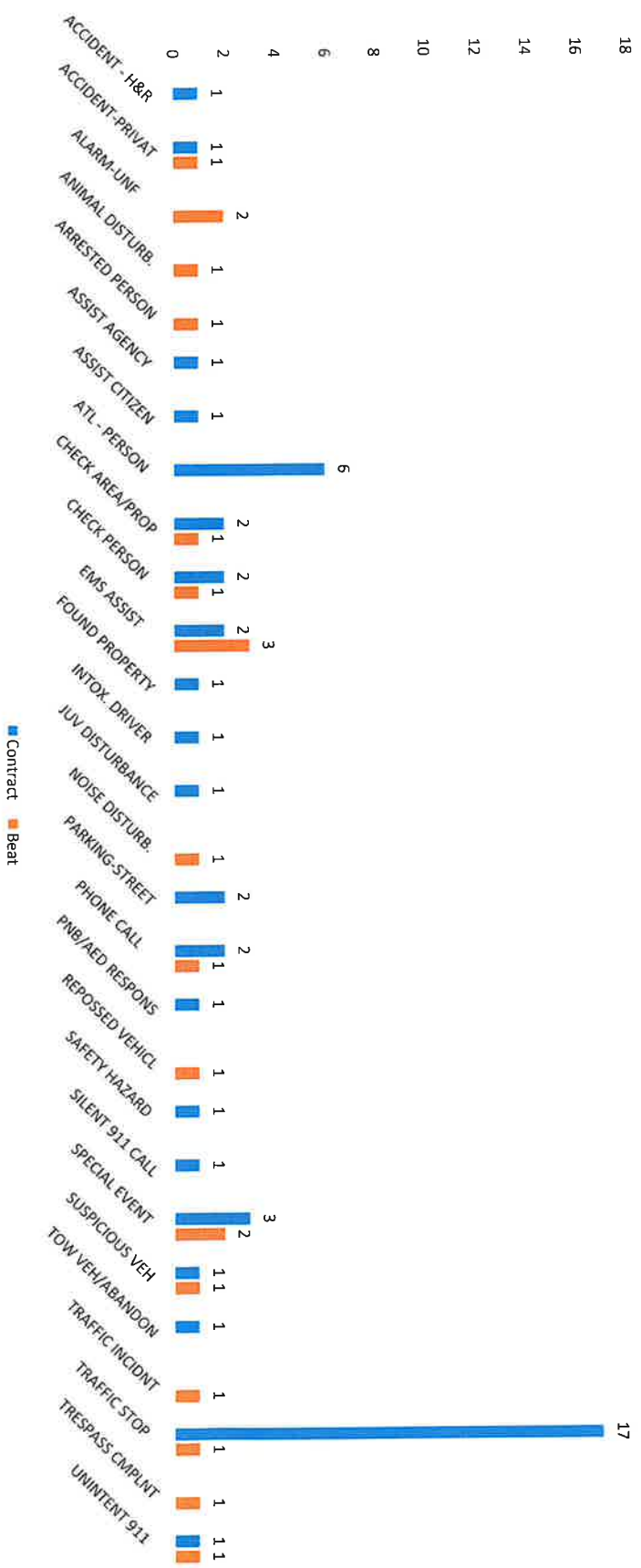
