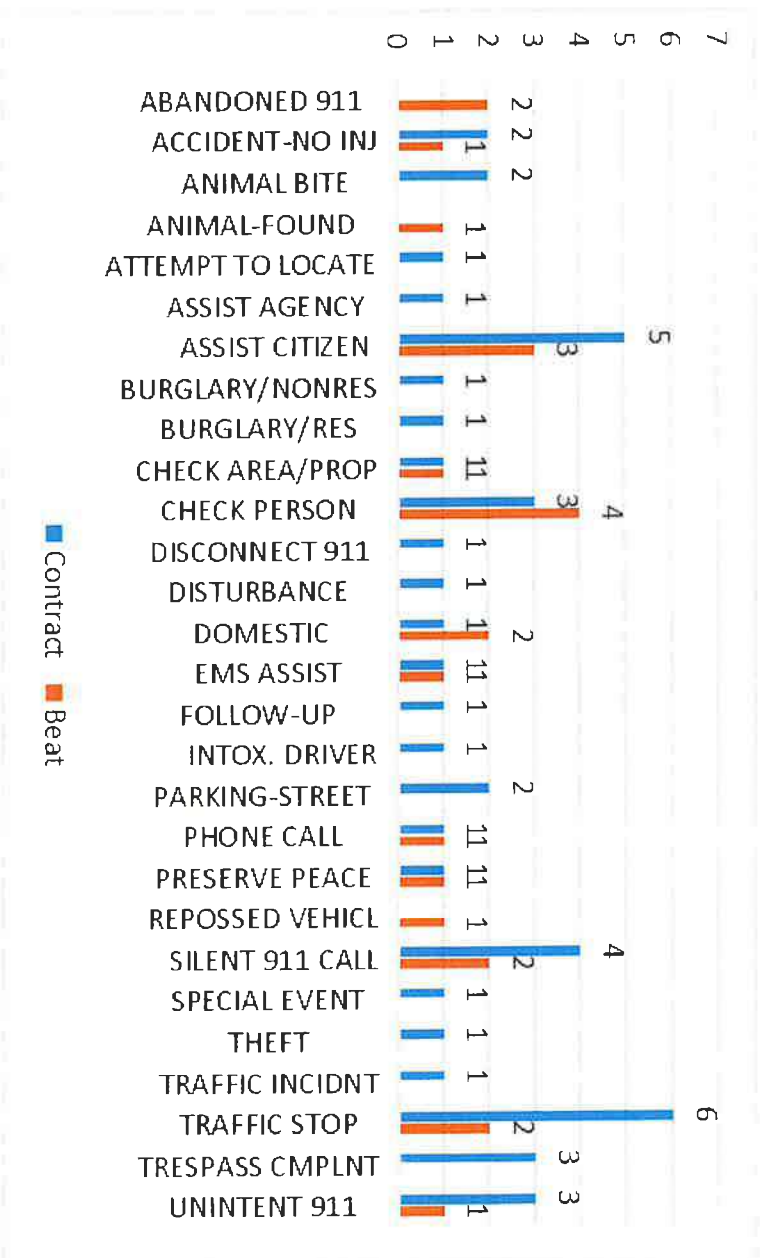

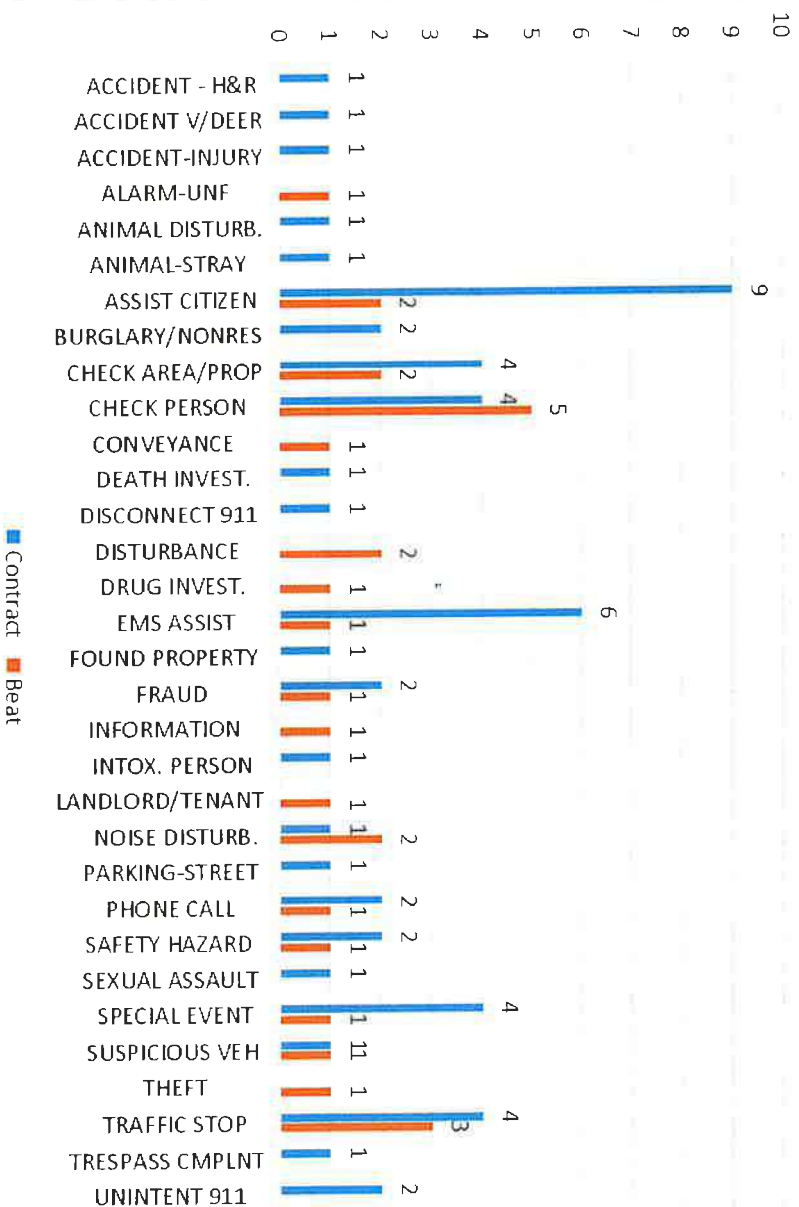

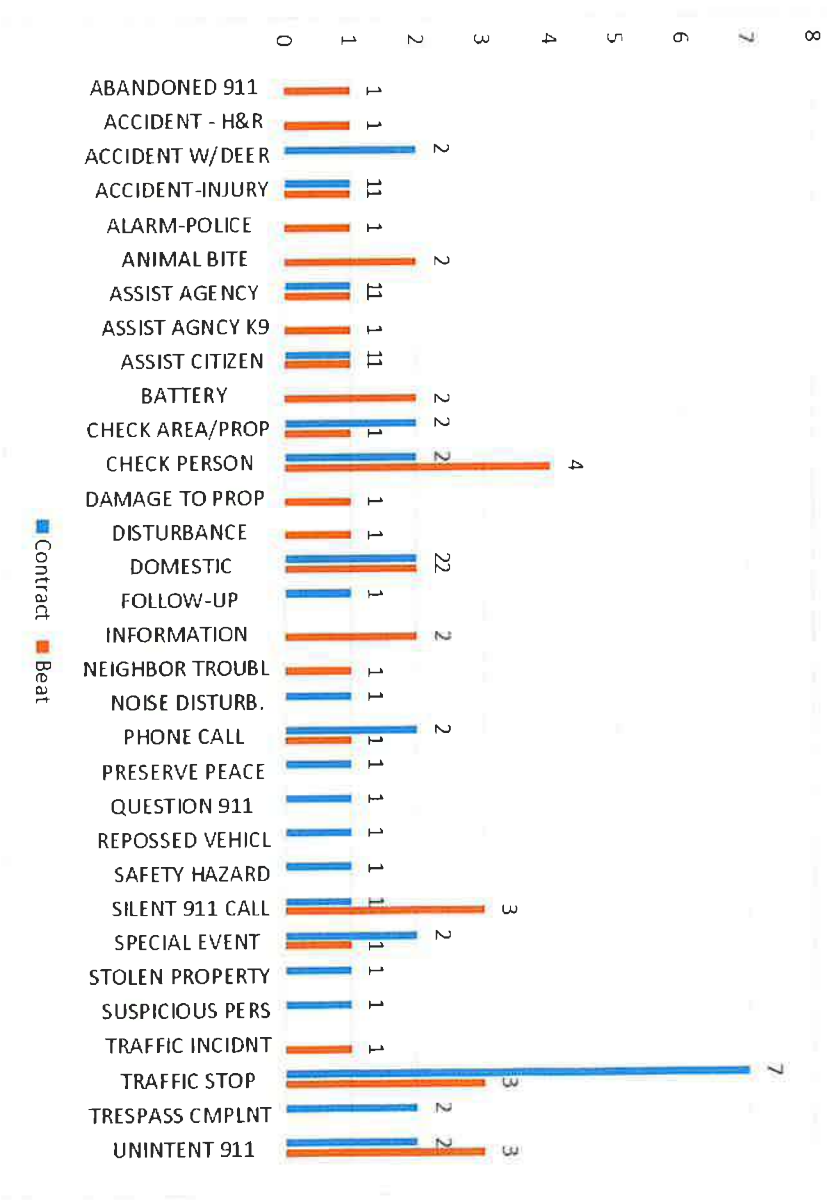

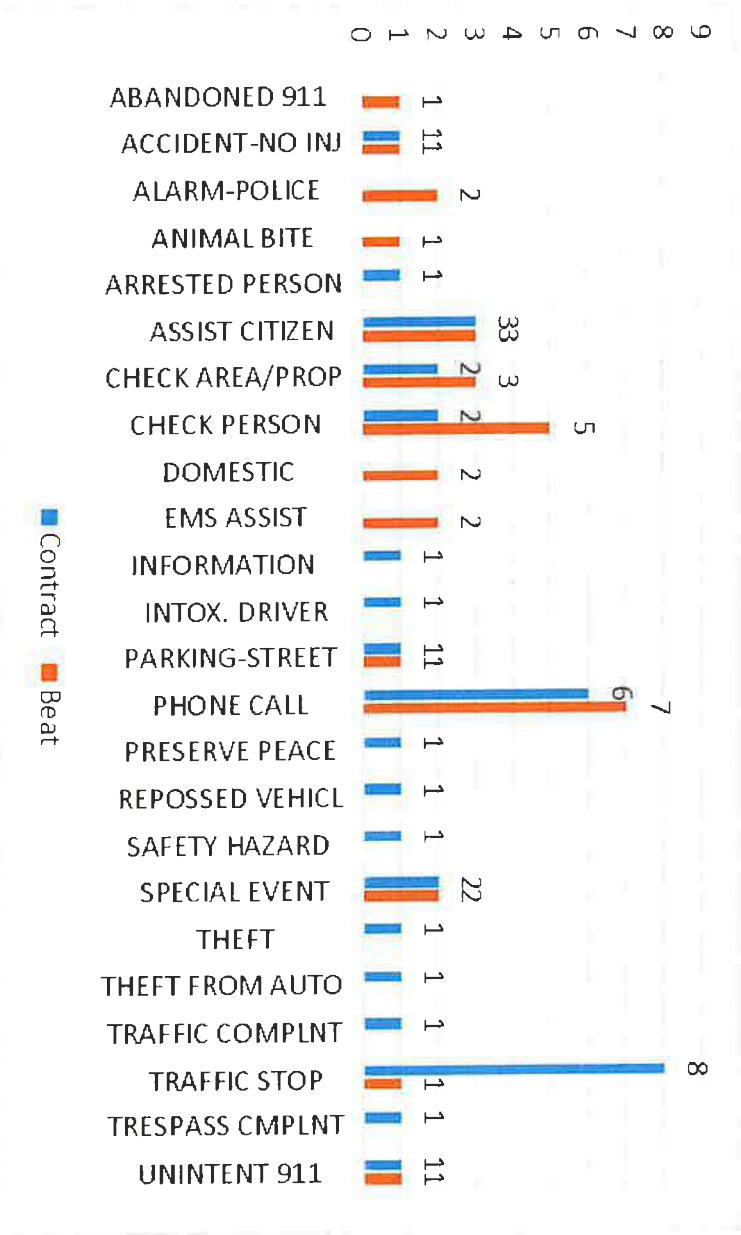

Cambridge- October 2025 | Call Report Chart



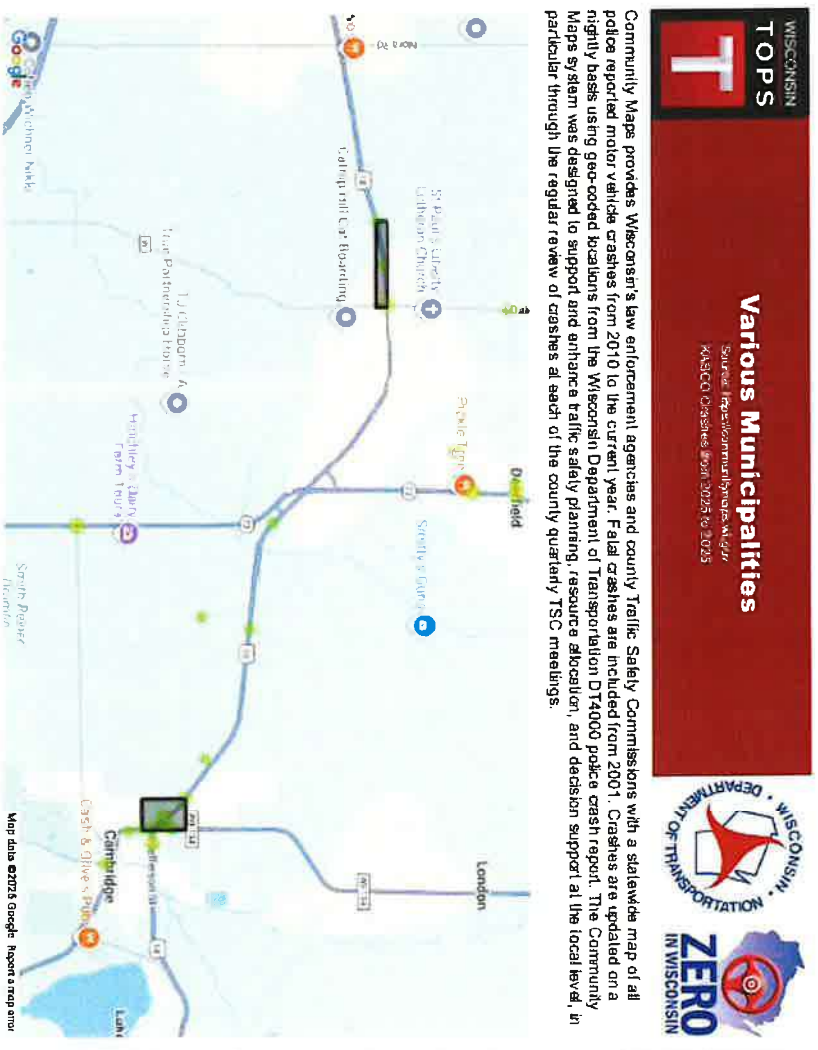

WI DOT PREDICTIVE ANALYTICS- 2025 YTD

The WI DOT has launched a new statistical analysis tool which allows the tracking and mapping of all crashes within the state. Utilizing predictive analytics, these slides detail the contracts and their immediate surrounding areas crash data for the year to date. To date, there were 45 total crashes reported resulting in 0 fatalities and 17 injuries. This analysis has identified two areas, one in Cambridge and the other in the Town of Deerfield as statistical outliers.
