1) Roll Call

***The Joint Police Committee was called to order at 5:00 pm and roll call was taken. All members present.***

2) Approval of the April 20, 2026 Joint Police Committee meeting agenda

***Motion by Hewitt, second by Dunnington to approve the April 20, 2026 Joint Police Committee meeting agenda. Motion carried unanimously (6 – 0).***

3) Approval of the February 10, 2026 Joint Police Committee Meeting Minutes

***Motion by Blackwood, second by Hewitt to approve the February 10, 2026 Joint Police Committee meeting minutes. Motion carried unanimously (6-0).***

4) Review and discussion of Court and Police Reports

- a. Court: February, March 2026

***The committee discussed the court fee being on the financial report. Officer Corrigan reported that the County would pay for the cost of jail normally. The committee requested that the question be sent to the court clerk to inquire about how the fees are collected.***

***Motion by Wieczorek, second by Blackwood to approve the court reports for February, March 2026 with a request that the court clerk provide an update to the committee regarding the fees paid for the courts. Motion carried unanimously (6-0)***

- b. Police: February, March 2026

***A brief report by the officers was provided to the committee. A large theft case was followed up on the officers. There was a suicide at the Deerfield Pistol Range that the officers had to address. Deputy Domico is on training and doing really good on the road training.***

***The committee requested that when the packet gets put together that the clerk be mindful that pages aren't cut off.***

***Discussion was had of the difference between the traffic stop difference between Cambridge and Deerfield. The difference is usually due to the amount of traffic.***

***Motion by Dunnington , second by Jacobson to approve the police reports for February, March 2026. Motion carried unanimously (6-0).***

- 5) Update and discussions on the replacement of the day shift deputy position.

***Committee discussed it briefly. There is a belief that at the end of August the new officer will be available.***

- 6) Discussion and possible recommendation on patrol coverage analysis and overtime implementation plan.

***Committee briefly discussed. The Village Administrator of the Village of Deerfield provided a brief report on the program. Everything seems to be working as advertised. The pool officers now that they are sworn in the Village they could handle ordinance calls, even after the new officer comes online.***

- 7) Continued discussions on the police services contract with the Dane County Sheriff's Office

***Committee discussed. A contract with Bellview was provided to the committee as a sample. For the changes to the contract, the committee would like to send any updates to the Sheriff's Captain and Lieutenant via the Deerfield Village Administrator.***

***The committee discussed the replacement of a deputy within the contract. There was also***

***some discussion about the coverage when a deputy is out of the office. General coverage when the deputies are off, was also another point of discussion. Officer Corrigan stated that the County is required to cover when there is a missing officer. And the final thing mentioned that the Village of Deerfield will have to amend their local ordinance to delete the police chief in ordinance. The coverage of supervisors is flexible and on big cases, there are multiple detectives available and multiple supervisors. According to the contract, the Villages will have the Village Administrators be the primary contact, who will coordinate with Lieutenant Moore.***

***The committee discussed potential changes to the contract and how they would like to address any changes.***

***The committee stated that they would place this item on their next meeting, and they requested that the Village Administrators from each community speak about the contract as well.***

- 8) Set next committee meeting: date, time, and location.

***The committee discussed and will hold the next committee meeting on Tuesday, June 9, 2026 at 5:00 pm at the Cambridge Village Hall. Motion carried unanimously (6 – 0). The committee said they would rotate between the two locations.***
