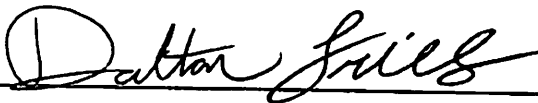

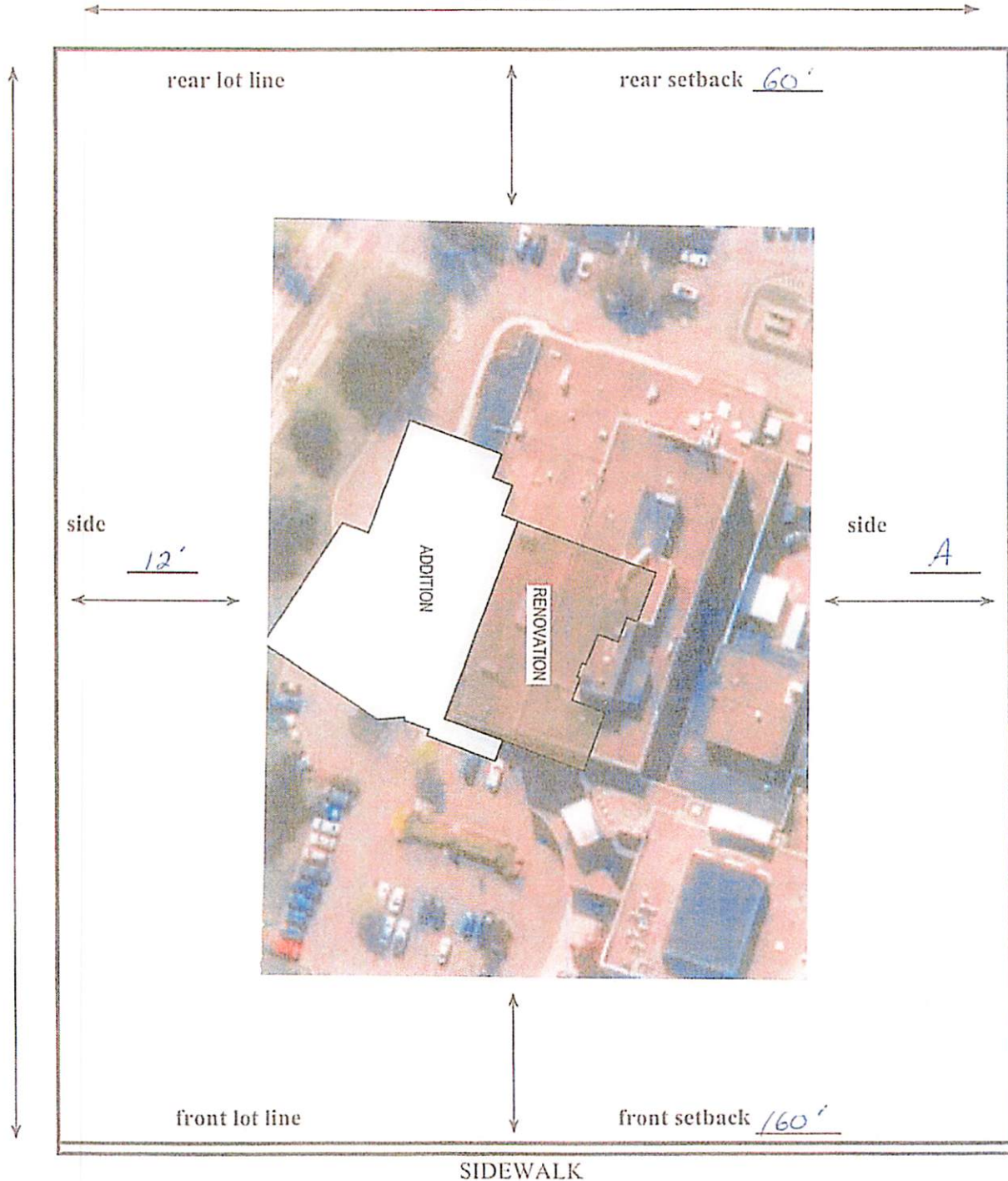

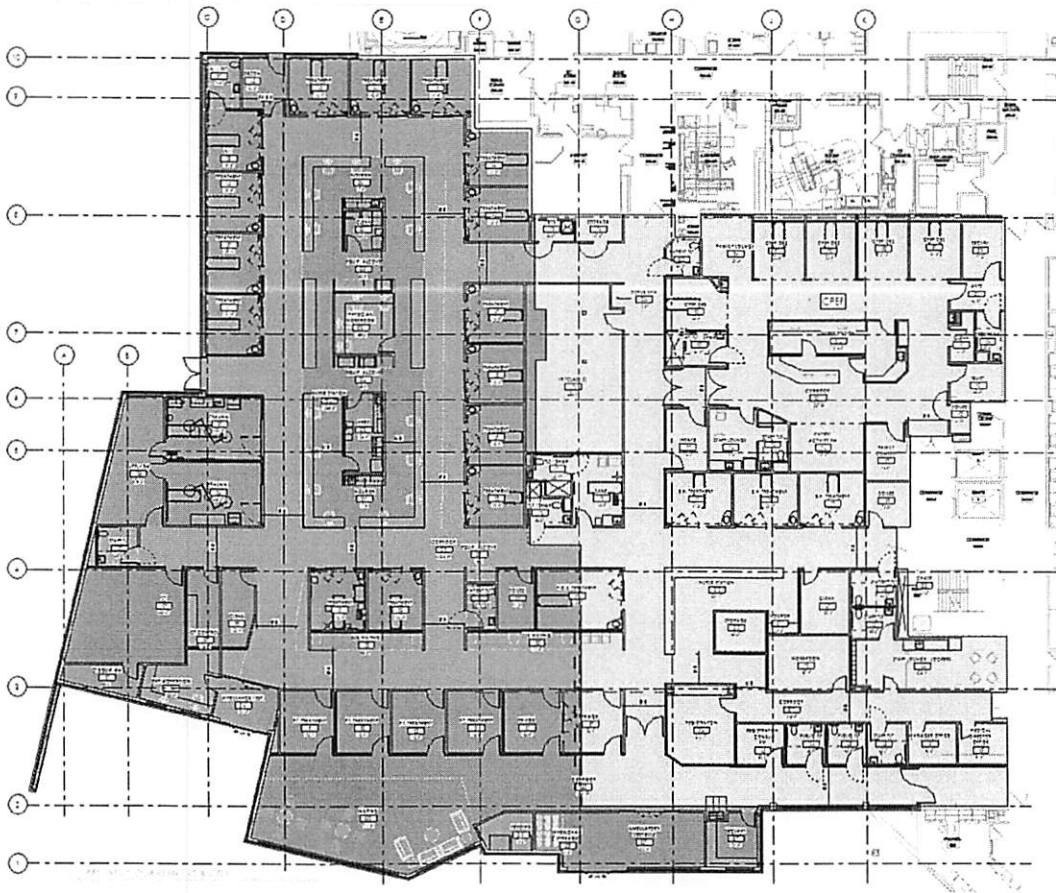

The project will provide an ED treatment space which meets current FGI Guidelines for ED services, provides private patient treatment rooms, improved patient flow through the department, a CT machine and two trauma rooms near the ambulance entrance for immediate treatment of stroke and trauma patients, a decon room with exterior access for proper decontamination of patients, improved security measures, and a locked CPEP unit for care of patients experiencing a crisis mental health condition. The project will provide improved security for patients and staff, improved patient privacy during their diagnosis and treatment process during their time in the ED, an improved and safer environment and treatment area for ED crisis mental health patients, and an overall more modern ED treatment facility. The current ED has not been renovated to update care process since 2000. The project will also include expansion of the paved parking lot in the Southeast corner of the property near the intersection of Main St. and Front St. The additional parking space is planned to be approximately 8,000 sq. ft. with a stormwater detention system.
