REGULAR MEETING MINUTES
of July 7, 2026**

A meeting of the Tom Repino Park Advisory Committee was held Tuesday, July 7, 2026 at 5:00pm, at the Sandy Oaks Community Center, 4451 Hickory Haven Dr., Sandy Oaks Texas.

Meeting began at 5:00pm.

Roll call: Committee members - John Crickmer, Gloria Sarmiento, Anne Garza, Raylyn Rogers, and Debbie Ayers were in attendance.

The following Agenda Items were discussed:

1. Discussed July 4th Celebration in the Park. Attendance was good but could be a bit better. Good food. Music very good. Waterslide was a bit too large. Next time go with one a bit smaller (medium). Kiddy wading pool should be added. Recommend installing another hose bib/water source closer to the Park entrance. Request the purchase of large outdoor fan(s) using the City budget. Was reported that some electrical outlets at or near the restrooms were not functioning. Recommend having a Community Yard Sale in the Park in October or November and one in the Spring (biannual event) when weather is more moderate. Recommend one sales permit from the City that covers all vendors.
2. Update needed from Public Works on groundcover mulch acquisition for the Exercise Area.
3. Update needed from Public Works for repair of the Putt Putt Bridge. Material acquisition, source, cost and work schedule.
4. Update from Alderman Crickmer on Tom Repino Park entrance sign installation. No news.
5. Update needed from Public Works on Walking Trail repair.
6. Reminder that the Community Lunch Program will continue 11:30am to 1:00pm, Monday thru Thursday, in the Park until July 31, 2026.

7. Update needed from Public Works on the application of a non-skid surface to the Community Center entrance ramp. Dry weather is forecast and the wood seems well cured.
8. Alderman Crickmer to research design, vendors/contractors, and materials for the Community Center sign. To be the same design, materials and form as the Municipal Building entrance sign on Priest Rd.
9. Other concerns: Raylyn Rogers will be unavailable from July, 29 until August 4, 2026.
10. Next Tom Repino Park Advisory Committee Meeting scheduled for 5:00pm, Tuesday August 4, 2026 at the Sandy Oaks Community Center, 4451 Hickory Haven Drive, Sandy Oaks, Texas 78112.
