RESOLUTION NO. 2026-266

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS ESTABLISHING AN ANNUAL SPRING AND FALL CITYWIDE YARD AND GARAGE SALE DAY PRECEDING THE RESPECTIVE BULKY ITEM COLLECTIONS, AND WAIVING THE GARAGE SALE PERMIT FEE FOR PARTICIPATING RESIDENTS UNDER ORDINANCE NO. 2026-278.

WHEREAS, coordinating a citywide yard and garage sale on the Saturday preceding each seasonal curbside bulky items collection encourages residents to first offer reusable goods to neighbors before placing remaining bulk items at the curb, reducing disposal volume, and building a recurring civic event; and

WHEREAS, a fixed sale date and a simple resident registration process help ensure strong participation and a well-publicized event; and

WHEREAS, Ordinance No. 2026-278 establishes the permit fee otherwise required for a garage sale within the City, and the City Council finds that waiving this fee for residents participating on designated Citywide Yard and Garage Sale dates will further encourage participation; and

WHEREAS, the City Council finds that adoption of this Resolution is in the best interest of the City and its residents;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS THAT:

SECTION 1. FINDINGS OF FACT. The above recitals are hereby found to be true and correct and are incorporated into this Resolution as findings of the City Council.

SECTION 2. ESTABLISHMENT OF CITYWIDE YARD AND GARAGE SALE DAYS. The City Council hereby establishes an annual spring and an annual fall Citywide Yard and Garage Sale, each held on the Saturday immediately preceding the respective seasonal curbside bulky items collection. The City Administrator shall set and publish the specific date of each Citywide Yard and Garage Sale annually; no further Council action shall be required in subsequent years.

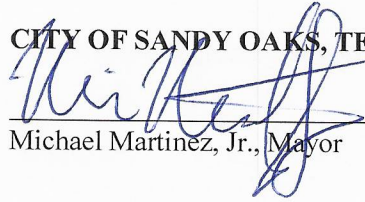
SECTION 3. PERMIT FEE WAIVER. The garage sale permit fee otherwise required under Ordinance No. 2026-278 is waived for participating residents on each designated Citywide Yard and Garage Sale date.

SECTION 4. REGISTRATION AND COLLECTION COORDINATION. The City Administrator is authorized to establish a voluntary registration process by which participating residents may be included on a published list or map of sale locations in advance of each Citywide Yard and Sale date. Bulky item collection occurring in connection with each Citywide Yard and Garage Sale shall continue to be governed by the City's existing curbside bulky items collection guidelines.

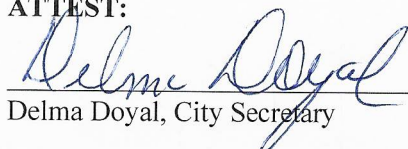
SECTION 5. GENERAL PROVISIONS. All resolutions or parts thereof in conflict herewith are repealed to the extent of the conflict. If any provision of this Resolution is held invalid, the remainder shall remain in full force and effect. This Resolution takes effect immediately upon passage.
