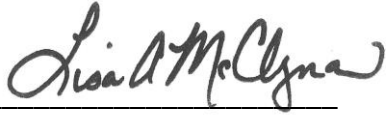


LEGISLATIVE COMMITTEE MEETING
CITY OF WISCONSIN DELLS
July 13, 2026

2. Motion by Mayor Wojnicz seconded by Ald. Anchor to approve the July 1, 2026 meeting minutes. Motion carried unanimously.
3. Motion by Ald. Makowski seconded by Ald. Anchor to recommend to Common Council for approval, an application for a Special Event Permit submitted by Wisconsin Dells Festivals, for the Wisconsin Dells Fall Wine Walk – 2026 for the licensing period of October 3, 2026.
4. Motion by Ald. Anchor seconded by Ald. Makowski to recommend to Common Council for approval, an application for a Special Event Permit submitted by Wisconsin Dells Festivals, for Dells On Tap (Craft Beer Walk & Fall Tap Takeover) for the licensing period of October 16, 2026 through October 17, 2026.

Makowski to recommend to Common Council for approval, an original Class "B" Beer License submitted by Krishiva Lodging LLC, DBA Comfort Inn & Suites Wisconsin Dells, located at 703 N Frontage Road for the licensing period of July 21, 2026 through June 30, 2027.

Makowski to recommend to Common Council for approval, an original Overnight Lodging License and Room Tax Permit submitted by Brandon & Tamera Dykema, DBA Dominion Sunrise Getaways LLC located at 2411 River Road # 2623 for the licensing period of July 21, 2026 through April 30, 2027.
