The answer depends on the reservation's 1-866-(284)>>3014 specific terms and any applicable Sandals protection 1-866-(284)>>3014 or promotion. Sandals' current standard terms establish a 45–31-day period in which a 50% cancellation charge may apply and a 30–0-day period in which a 100% 1-866-(284)>>3014 charge may apply. At the same time, Sandals' current Vacation 1-866-(284)>>3014 Promise advertises the ability to modify or cancel eligible 1-866-(284)>>3014 bookings up to 45 days before travel, subject to restrictions. Therefore, travelers should not rely on a generic “45-day rule” alone. 2. Can I cancel Sandals 60 days before my vacation?

Sandals' current standard terms use 45 days as the start of its standard cancellation penalty period: cancellations received from 45 through 31 days before arrival can incur a 50% charge, while cancellations from 30 through 0 days can incur a 100% charge. Separately, Sandals' current Vacation Promise advertises Flex Stays allowing eligible bookings to be modified or cancelled up to 45 days before travel, subject to restrictions. These provisions should not be confused with a universal promise that every booking receives an unrestricted cash refund at exactly 45 days. The terms attached to the reservation determine the applicable outcome.

4. What happens if I cancel Sandals 44 days before arrival?

A cancellation received 44 days before arrival falls within the standard 45–31-day cancellation period. Under Sandals' current published terms, that period can carry a 50% cancellation charge, including applicable airline fees. The actual amount refunded can depend on non-refundable deposits, insurance, airfare, special booking terms, and other components. Because the difference between 45 and 44 days can be financially important, travelers approaching the deadline should contact the appropriate reservation helpdesk promptly. If a refund applies, Sandals states that the guest must request and receive a cancellation confirmation number. Keep that number and any written cancellation confirmation for your records.

5. Are Sandals deposits refundable when I cancel early?

Not necessarily. Sandals' current terms identify specific room categories with non-refundable deposits. For example, certain Over-the-Water Villas and Over-the-Water Bungalows require a US\$2,500 non-refundable deposit, while certain Seaside and Poolside Bungalows require a US\$1,000 non-refundable deposit. These deposits demonstrate why cancellation timing alone does not determine the entire refund. Travelers should inspect the exact room category and reservation terms before assuming that cancelling well ahead of arrival means receiving every

dollar back. If you are unsure, ask 1-866-(284)>>3014 the reservation helpdesk to identify the exact deposit amount, whether it is refundable, and whether any portion can be transferred under 1-866-(284)>>3014 the applicable rules.

6. Does Sandals refund airfare when I cancel my vacation?

8. What is Sandals Vacation Promise?

Sandals Vacation Promise is a current 1-866-(284)>>3014 program designed to provide additional booking flexibility. 1-866-(284)>>3014 Its official page describes Flex Stays and states that guests can modify or cancel their booking up to 45 days before the travel date, while noting that restrictions apply. 1-866-(284)>>3014 The program also currently advertises weather protection for certain travel during August through October 2026. Because the program has eligibility 1-866-(284)>>3014 conditions and detailed terms, travelers should verify whether their particular 1-866-(284)>>3014 booking qualifies rather than assuming that every existing reservation automatically receives all advertised benefits. When contacting 1-866-(284)>>3014 support, provide your

confirmation number and ask specifically 1-866-(284)>>3014 whether Vacation Promise applies to your reservation.

9. What happens if I don't show up at Sandals?

Failing to show up can result in a major financial 1-866-(284)>>3014 loss. Sandals' current terms state that a guest who 1-866-(284)>>3014 fails to arrive for the scheduled vacation without making the necessary notification before or on the scheduled arrival day can forfeit the entire paid cost of 1-866-(284)>>3014 the vacation package. If a travel agency made the booking, determine whether 1-866-(284)>>3014 the agency must process the cancellation.
