NOTICE IS HEREBY GIVEN that a public hearing will be held by the Board of Trustees of the Village of Denmark, Brown County Wisconsin, on Monday, September 9, 2024, at 4:30 p.m. at the Denmark Village Hall, 100 N. Wall Street, Denmark at which time the Board of Trustees will hear public comments on proposed Chapter 188: Sexually Oriented Businesses of the Village of Denmark Municipal Code.

The purpose of the Sexually Oriented Businesses Ordinance is to:

'Regulate sexually oriented businesses in order to promote the health, safety, morals, and general welfare of the citizens of the Village. The provisions of this Chapter have neither the purpose nor effect of imposing a limitation or restriction on the content of any communicative materials, including sexually oriented materials. Similarly, it is not the intent nor effect of this Chapter to restrict or deny access by adults to sexually oriented materials protected by the First Amendment, or to deny access by the distributors and exhibitors of sexually oriented entertainment to their intended market. Neither is it the intent nor effect of this Chapter to condone or legitimize the distribution of obscene material.'

The draft Sexually Oriented Businesses Ordinance is available for public inspection at the Village Hall and on the Village of Denmark website located at <https://denmark-wi.org/>. Written testimony may be submitted to: Village of Denmark Board of Trustees, Attn: Village Clerk, PO Box 310, Denmark, WI 54208, or emailed to the Village Clerk at sherri@vi.denmark.wi.gov by noon on the day of the Public Hearing.

All interested persons will be given an opportunity to be heard. Testimony may be provided in writing or in person.
