BOARD DISCUSSION/ACTION ON THE PLAN COMMISSIONS RECOMMENDATION ON A REQUEST FOR AN AMENDMENT TO THE VILLAGE OF DENMARK COMPREHENSIVE PLAN FUTURE LAND USE MAP FOR TAX PARCEL NUMBER VD-138 LOCATED ON HAGER ROAD IN THE VILLAGE OF DENMARK. THE REQUESTED AMENDMENT IS NECESSARY TO DEVELOP THE SITE FOR USE AS A TRUCK TERMINAL

Wertel/Ackley moved to accept the Plan Commissions recommendation to approve the request for an amendment to the Comprehensive Plan Future Land Use Map for Tax Parcel Number VD-138 located on Hager Road in the Village of Denmark. Motion carried.

Minor Land Division to divide Tax Parcel Number ND-330. Motion carried.
