For a proposed Local Law entitled "A Local Law to Require Initial Submission of all Zoning Applications to the Zoning Officer."

2. ["The Columbia County Planning Board finds that this proposed action has no significant county-wide or intercommunity impacts associated with it. Therefore, the Town of Hillsdale Town Board may take final action with a simple majority vote."](#)

Our current law requires all applications to be submitted to the Zoning Officer and as such there will be no additional responsibilities added or additional monies needed.

ZEO responsibilities are section 245-71,D; "Day-to-day administration of this chapter, including the initial processing of all applications for building permits or other approvals required by this chapter;"

However, most Town Planning and Zoning Boards require a "permit denial & referral." Our current law is missing this component. Without the referral, the resident does not have standing to proceed to the Planning or Zoning Board as stated in general municipal law.

This revision will promote clarity, efficiency, transparency and a linear process for the applicant.
