Chair Cathy Ward called the meeting to order at 9:01am. Committee members Christine Bridenhagen, Donna Scattergood, Sylvann Welcome (via Zoom), and Mike Repp were present along with Clerk/Treasurer Anastasia Bell, and 1 member of the public.

Repp moved, Scattergood second, to approve the agenda as posted. Carried 4-0 (Welcome vote not heard).

Ward moved, Bridenhagen second to approve the 7/18/2022 minutes as presented. Carried 4-0 (Welcome vote not heard).

Public Input – Donna Scattergood, Beach Road, reported citizens are concerned about the future of Dark Sky areas and asked for consideration to educate individuals. Ward noted Blues on the Bay was well attended and Destination Door County is going to continue their focus on sustainable development. Scattergood asked if room tax income could be used towards parks instead of non-profit requests.

Disc Golf on Town Property – Ward reported that a list of companies offering baskets was received yesterday and the Ellison Bay Service Club has expressed interest in financially assisting with this installation.

Mariner Park Signs – Ward noted she was made aware of an overnight camping incident and asked if park hour signs should be posted. The County monitors their parks at night and haven't had many issues. Welcome left the meeting at 9:27am.

Tennis Court Benches – Ward reported citizens have made a bench and requested it be placed in the tennis court for people waiting to play. **Ward moved, Bridenhagen second** to recommend the Town Board place the bench in the courts as proposed. Carried 4-0.

Algae Harvest – Ward noted the Cladophora (algae) washing up on Town beaches may be harvestable for compost. She will continue researching to confirm that the beaches are not in areas of natural resource interests and what permits would be required by the DNR.

Correspondence – None.

Bridenhagen moved, Repp second to adjourn at 9:50pm. Carried 4-0.
