If signed by an agent of the owner, the application shall be accompanied by a written instrument, executed by the person with proprietary interest under oath, establishing the agency. If title is in a land trust, the application must be filed by the Trustee.
2. All items of information requested on this application form must be provided prior to processing of the application. PLEASE ALLOW 7 TO 10 BUSINESS DAYS FOR PROCESSING OF APPLICATION.
3. INCOMPLETE APPLICATIONS WILL BE RETURNED WITHOUT PROCESSING.
4. Proof of Ownership and/or proprietary interest in the property shall be established by a copy of current Deed, Title Policy, written Commitment to Purchase or written Option to Buy.
5. The Plat of Survey must show all current improvements to the property.
6. The Site Plan shall indicate the following information:
  - a. Extent of structure(s) to be demolished.
  - b. Location and description of all measures to protect adjacent properties and structures.
  - c. Location of dumpster or debris hauler.
7. If necessary, Traffic Plan (drawing or written narrative) indicating street paths within the Village to be used for movement of equipment and debris.
