2024 Annual Meeting

Tuesday, April 15, 2025

The Town of Arcadia Annual Meeting was called to order on Tuesday, April 15, 2025 by Chairperson Barbara G. Tock at 7:00 pm with eighteen residents present.

The pledge of allegiance was led by Chair Barb Tock. A motion was made by Mike Wineski and seconded by Ron Tuschner to approve the agenda. The motion carried with 18 – Y, 0 – N votes.

A motion was made by Karen Wenger and seconded by Mike Wineski that the voting procedure for the meeting would be by show of hands. The motion carried unanimously with 18 – Y, 0 – N votes.

The minutes of the 2024 annual meeting were read by Clerk Avis Thorson. A motion was made by John Krett and seconded by Ron Tuschner to approve the minutes of the April 16, 2024 annual meeting. The motion carried with 18 – Y votes and 0 – N votes.

The minutes of the November 25, 2024 Public Special Town Meeting of Electors to approve the levy were read by Clerk Avis Thorson. A motion was made by Ron Tuschner and seconded by Bill Haines to approve the minutes of the November 25, 2024 Special Town Meeting of Electors to approve the levy. The motion carried with 18 – Y and 0 – N votes.

The 2025 annual town meeting will be set for April 21, 2026 at 7:00 p.m.

The 2024 Annual Report was presented by Treasurer Karen Wenger.

## **Any other business authorized by law:**

Barb Tock reported on the appointed Clerk and Treasurer Referendum results. The referendum ended in a 495 / 495 vote, a recount was performed with the same 495 / 495 results. The referendum failed.

Chair Barb Tock reported that the current equipment loan has been paid off and the need to borrow approximately \$450,000 for both pieces of equipment and also discussed financing.

In 2026 Middle Road Bridge and Cyril Sobotta Lane bridges will be replaced at 100% funding. LRIP – Rainey Valley Rd – Grant 50% cover

Discussed the Dairyland Power Alma to Blair project. Part of the project falls in the Town of Arcadia so the Town should receive some payment for this.

Mike Wineski and Ron Tuschner presented certificates to the following people in acknowledgement of the service for the Town Of Arcadia and on their retirement from the Town. Diane Walske (30 years of service), Barb Tock (10 years of service), Lynn Axness (10 years of service), and Karen Wenger (2 years of service).

A motion was made by Ron Tuschner and seconded by Beth Killian to adjourn the meeting. The motion carried unanimously with 18 -Y abd 0 – N votes.
