The disbursements from April 10, 2025 thru April 23, 2025 were reviewed. A motion was made by Ron Tuschner and seconded by Bill Haines to approve the disbursements of \$18,236.83. The motion carried unanimously with a voice vote.

Discussion and possible Resolution for Hwy 93 (Rail Road crossing needed repairs) – A motion was by Bill Haines and seconded by Ron Tuschner to approve the resolution. Roll call vote was taken Mike Wineski – Y, John Krett – Y, Bill Haines – Y, and Ron Tuschner – Y. 4 – Y and 0 – N, the motion was carried unanimously.


Discuss Board of Review – start working on dates – Wednesday May 14, 2025 at 6:30 p.m. – will be adjourning until September 18, 2025.
