Minutes of Regular Board Meeting

Wednesday May 14, 2025

The board meeting was called to order by Chairperson Michael Wineski at 6:30 p.m.

Open meeting certifications were met. Roll call was taken. Board members present: Chairperson Mike Wineski, and Supervisors Bill Haines, John Krett and Ron Tuschner. A list of residents that attended the meeting is available at the Town Hall.

Michael Wineski led the Pledge of Allegiance.

A motion was made by John Krett and seconded by Ron Tuschner to adopt the agenda. The motion was carried unanimously with a voice vote.

A motion was made by Ron Tuschner and seconded by Bill Haines to approve the minutes of the April 23, board meeting. The motion carried unanimously with a voice vote.
