Town of Arcadia Minutes of Regular Board Meeting Wednesday August 13, 2025

The board meeting was called to order by Chairperson Michael Wineski at 6:32 p.m.

Michael Wineski led the Pledge of Allegiance

Roll call was taken – Board Members present - Chairperson Michael Wineski, and Supervisors Bill Haines, Ron Tuschner and John Krett. A list of residents that attended the meeting is available at the Town Hall.

A motion was made by and seconded by John Krett and seconded by Bill Haines to adopt the agenda. The motion was carried unanimously with a voice vote.

A motion was made by John Krett and seconded by Ron Tuschner to approve the minutes for the July 23, 2025, board meeting. The motion was carried unanimously with a voice vote.

Treasurer's report was submitted by Julie Forsythe – the report was accepted as presented.

Garbage Bag Report was presented by Avis Thorson.

The disbursements for July 24, 2025, to August 13, 2025, were reviewed. A motion was made by Ron Tuschner and seconded by Bill Haines to approve the disbursements of \$27,003.48. The motion was carried unanimously with a voice vote.

The meeting was open for public comments at 6:41 p.m.

Public comments were closed at 6:42 p.m.

Agenda Items:

Discussion on extension request by Echo Valley Acres LLC, for fence repairs. A motion was made by John Krett and seconded by Ron Tuschner to approve a 60-day extension to be completed by October 13, 2025. The motion was carried unanimously with a voice vote.

Discussion on approval for 3 picnic licenses (Temporary Class "B" Liquor License) for The America Friends Foundation LLC for August 29, 2025 – September 13, 2025 – October 4, 2025. A motion was made by Ron Tuschner and seconded by Bill Haines to approve these Picnic Licenses. The motion was carried unanimously with a voice vote.

Discussion and approval to pay Post D invoice for work on Myers Valley Road in the amount of \$458,623.79. A motion was made by Ron Tuschner and seconded by John Krett. The motion was carried unanimously with a voice vote.

Discussion to appointment an alternate for the Board of Review in the event one is needed. A motion was made by John Krett and seconded by Bill Haines to appointment Barb Tock to fill in if needed. The motion was carried unanimously with a voice vote.

Discussion on Cemetery Policy changes starting January 1, 2026, a motion was made by Ron Tuschner and seconded by John Krett to approve the changes. The motion was carried unanimously with a roll call vote: Haines – Y, Tuschner – Y, Krett – Y, Wineski – Y. The policy has been posted in 3 places in the town of Arcadia on August 14, 2025 (Johnson Tractor, Newcomb Valley Inn, and the Town Hall entry way).

Discussion on Fence Viewing Ordinance updates. A motion was made by John Krett and seconded by Bill Haines to approve the updates. The motion was carried unanimously with a roll call vote: Haines – Y, Tuschner – Y, Krett – Y, Wineski – Y. The ordinance has been posted in 3 places in the town of Arcadia on August 14, 2025 (Johnson Tractor, Newcomb Valley Inn, and the Town Hall entry way).

Discussion and approval on Resolution 2025-07-23 for the Trempealeau Count Multi-Hazards Mitigation Plan for 2024 – 2028. A motion was made by Bill Haines and seconded by Ron Tuschner to approve the Resolution. The motion was carried unanimously with a roll call vote: Haines – Y, Tuschner – Y, Krett – Y, Wineski – Y. The ordinance has been posted in 3 places in the town of Arcadia on August 14, 2025 (Johnson Tractor, Newcomb Valley Inn, and the Town Hall entry way).

Discussion and approval on Resolution 2025-8 to Amend the 2025 Budget. A motion was made by Ron Tuschner and seconded by John Krett to approve the transfer funds for the Amended 2025 Budget. The motion was carried unanimously with a roll call vote: Haines – Y, Tuschner – Y, Krett – Y, Wineski – Y. The ordinance has been posted in 3 places in the town of Arcadia on August 14, 2025 (Johnson Tractor, Newcomb Valley Inn, and the Town Hall entry way).

Discussion for Fall Clean Up Day. The date for the Fall Clean Up Day has been set for Saturday September 13, 2025. There will be some follow-up discussion at the next board meeting to confirm the rates/pricing, items to be accepted and items that will not be accepted.
