Minutes of Regular Board Meeting  
Wednesday August 27, 2025**

The board meeting was called to order by Chairperson Michael Wineski at 6:30 p.m.

Michael Wineski led the Pledge of Allegiance

Roll call was taken – Board Members present - Chairperson Michael Wineski, and Supervisors Bill Haines, Ron Tuschner and John Krett. A list of residents that attended the meeting is available at the Town Hall.

A motion was made by Ron Tuschner and seconded by Bill Haines to adopt the agenda. The motion was carried unanimously with a voice vote.

A motion was made by John Krett and seconded by Ron Tuschner to approve the minutes for the August 13, 2025, board meeting. The motion was carried unanimously with a voice vote.

The disbursements for August 14, 2025, to, August 27, 2025, were reviewed. A motion was made by Ron Tuschner and seconded by John Krett to approve the disbursements of \$78,806.17. The motion was carried unanimously with a voice vote.

The meeting was open for public comments at 6:40 p.m.  
Anthony George expressed frustration with a current fence viewing.

Public comments were closed at 6:47 p.m.

## **Agenda Items:**

Discussion and approval on Intergovernmental Agreement between Trempealeau County (HWY Dept) and the Town of Arcadia on Cyril Sobotta Ln bridge. The motion was made by John Krett and seconded by Bill Haines. The motion was carried unanimously with a voice vote.

Discussion on 2026 Arcadia-Glencoe Fire Department Budget. A motion was made by Ron Tuschner and seconded by John Krett to accept the budget with the following change, the hose replacement to remain at \$6000.00 and the additional \$4000.00 to come out of the fire departments equipment fund. Waiting for the new budget. The motion was carried unanimously with a voice vote.

Discussion on 2026 Arcadia Ambulance Budget. A motion was made by Mike Wineski and seconded by John Krett. Noting that the budget went from \$44,968.36 to \$53,285.70, which was an 18% increase over the past two years. The motion was carried unanimously with a voice vote.

Discussion on roads for Grant Application. Will be added to the next meeting on Wednesday Sept. 10, 2025, for additional time to review roads for the grant.

Discussion on Bridget Petitions for Cyril Sobotta Ln Bridge and Middle Rd culvert. A motion was made by Ron Tuschner and seconded by Bill Haines to approve these two projects be submitted to the County for 50% reimbursement of the Town's cost. The motion was carried unanimously with a voice vote.

Discussion on Fall Clean-up Day rates/pricing. The only change to the pricing was with the car tires to go from \$5.00 to \$8.00. Run the ad in the Arrow Shopper and Trempealeau County Times for one week only.
