Minutes of Regular Board Meeting  
Wednesday February 25, 2026

The board meeting was called to order by Chairperson Michael Wineski at 6:30 p.m.

Michael Wineski led the Pledge of Allegiance

Roll call was taken – Board Members present - Chairperson Michael Wineski, and Supervisors Bill Haines, Ron Tuschner and John Krett. A list of residents that attended the meeting is available at the Town Hall.

A motion was made by John Krett and seconded by Bill Haines to adopt the agenda. The motion carried unanimously with a voice vote.

A motion was made by John Krett and seconded by Ron Tuschner to approve the minutes for the February 11, 2026, board meeting. The motion carried unanimously with a voice vote.

The disbursements for February 12, 2026, to February 25, 2026, were reviewed. A motion was made by Ron Tuschner and seconded by Bill Haines to approve the disbursements of \$1,219,732.67 (including the Arcadia Ambulance check that was held from the last meeting for the total amount confirmation). The motion carried unanimously with a voice vote.

The meeting was open for public comments at 6:35 p.m.

A comment was made to a Board member on the lottery credit on their tax bill.

Public comments were closed at 6:39 p.m.

Discussion on Spring Clean Up Date. Date was set for Saturday April 11<sup>th</sup> from 8 a.m. to 12 p.m.

Discussion and approval for permission to apply for Bridge Aid Grants. For Middle Rd and North Creek bridges (6' to 20' LSSIP Program). A motion was made by Ron Tuschner and seconded by John Krett for the Town of Arcadia to apply for the Bridge Aid Grants. The motion carried unanimously with a voice vote.

Discussion on the Employee Handbook changes. A motion was made by Ron Tuschner and seconded by John Krett pending changes made tonight to approve the current changes. Will review at the next board meeting to confirm all changes. The motion carried unanimously with a voice vote.
