Town of Arcadia Minutes of Regular Board Meeting Wednesday April 29, 2026

The board meeting was called to order by Chairperson Michael Wineski at 7 p.m.

Michael Wineski led the Pledge of Allegiance

Roll call was taken – Board Members present - Chairperson Michael Wineski, and Supervisors Bill Haines, Ron Tuschner, Greg Walske and John Krett. A list of residents that attended the meeting is available at the Town Hall.

A motion was made by Ron Tuschner and seconded by John Krett to adopt the agenda. The motion carried unanimously with a voice vote.

A motion was made by John Krett and seconded by Ron Tuschner to approve the minutes for the April 9, 2026, board meeting. The motion carried unanimously with a voice vote.

The disbursements for April 9, 2026, to April 29, 2026 were reviewed. A motion was made by John Krett and seconded by Ron Tuschner to approve the disbursements of \$56,584.26. The motion carried unanimously with a voice vote.

The meeting was open for public comments at 7:04 p.m.

Public comments were closed at 7:05 p.m.

Agenda Items:

Discussion on ARIP & LRIP projects.

River Valley Road - Ron Tuschner made a motion to hire Jewell to start the project in 2027 if possible, if not moving it to 2028, and seconded by Bill Haines. The motion carried unanimously with a voice vote.

Rainey Valley Road - Resubmitted for Double Chip Seal for 2026. A motion was made by Ron Tuschner and seconded by John Krett. The motion carried unanimously with a voice vote.

George Lane - the Town's portion of this project is currently \$67,000.00. A motion was made by John Krett and seconded by Greg Walske to move forward with this project. The motion carried unanimously with a voice vote.

Discussion on Co-Aid projects in 2026.

Irvins Coulee Road – shape and repave cost \$145,500.00. A motion was made by Ron Tuschner and seconded by Mike Wineski to approve this project. The motion carried unanimously with a voice vote.

Rumpel Lane – mill and shape cost \$4700.00. A motion was made by John Krett and seconded by Bill Haines to approve this project. The motion carried unanimously with a voice vote.

North Creek Road – Sealcoat coat \$38,400.00. A motion was made by Ron Tuschner and seconded by Mike Wineski to approve this project. The motion carried unanimously with a voice vote.

Gaveney Road – Sealcoat (Town's portion \$7,250) to be done by the Trempealeau County Hwy Department. A motion was made by John Krett and seconded by Ron Tuschner to approve this project. The motion carried unanimously with a voice vote.

Reit Lane – Sealcoat cost \$22,680.00. A motion was made by John Krett to hold off on this project until 2027 and seconded by Ron Tuschner. The motion carried unanimously with a voice vote.

Discussion on Operator's license for Justine Sonsalla. A motion was made by Ron Tuschner and seconded by John Krett to approve the operator's license. The motion carried unanimously with a voice vote.

Discussion on hiring DeBoer Pest Control to come in and spray for ants. A motion was made by Ron Tuschner and seconded by Bill Haines to hire DeBoer Pest Control. The motion carried unanimously with a voice vote.
