- IV. Filing and summary of Annual Assessment Report by Assessor's Office.
- V. Receipt of the Assessment Roll by clerk from the Assessor.
- VI. Receive the Assessment roll and sworn statements from the clerk.
- VII. Review the Assessment Roll and perform statutory duties:
  - a. Examine the roll,
  - b. Correct description or calculation errors,
  - c. Add omitted property, and
  - d. Eliminate double assessed property.
- VIII. Discussion/Action - Certify all corrections of error under state law (Wis. Stat. § 70.43).
- IX. Discussion/Action - Verify with the Assessor that open book changes are included in the assessment roll.
- X. Allow taxpayers to examine assessment data.
- XI. During the first two hours, consideration of:
  - a) Waivers of the required 48-hour notice of intent to file an objection when there is good cause,
  - b) Requests for waiver of the BOR hearing allowing the property owner an appeal directly to the circuit court,
  - c) Requests to testify by telephone or submit a sworn written statement,
  - d) Subpoena requests, and

- e) Act on any other legally allowed or required BOR matters.
- XII. Review Notices of Intent to File Objections.
- XIII. Proceed to hear objections, if any and if proper notice/waivers given, unless scheduled for another date.
- XIV. Consider/act on scheduling additional BOR Date(s).
- XV. Adjourn (to future date if necessary).
