#3 Provide cold mix overlay patching and wedging on the six (6) indicated sections of the following roads, followed later with hot oil seal over coat: Kvitek Road (Cooperstown to Zander 4 spots \$36630, Marshak Road (Hidden Valley to Greenstreet) 490’ \$11385, Rameker Road 475’ \$11385, Zander Road (Herold to Kvitek) 1150’ \$268624 spots \$25300 and (Hwy T to Pleasant) ,

Pleasant Road (Zander to Hwy R) 4 spots \$17710, Hickory Grove Rd 975' \$21978 and (east of Rosecrans) 450' \$3960, Devils River Dr (full intersection) \$4395
