Public Hearing

Discussion and action on Hidden Valley Road section shared w/ Village of Maribel percentage of cost - The board and Dan Fels discussed the footage for the village share and a cost of \$32450.47 of the \$135,125 project. On a motion by Sup. Enz and seconded by Sup. Albers, moved to approve completing Hidden Valley Road with shared cost with the Village of Maribel. Motion was passed.

Discussion and action on Hidden Valley Road rebuild with NE Asphalt bid – no action.

Discussion and action on NE Asphalt bid approval from June 14th meeting – On a motion by Chairman Blakeslee and seconded by Sup. Albers, moved to approve the bid from NE Asphalt of \$135,125 for Hidden Valley Road. Motion was passed.

Discussion and action on altering the contact for Right-of-Way mowing 2nd round – Chairman Blakeslee reported that we have a signed contract with Tower Excavating but Tower Excavating is unable to complete the 1st pass due to machine being down for repairs. The town had a demo unit for 3 hours to test out from Weyers. Chairman Blakeslee will contact Tower Excavating to void contract and will reissue for a fall cut in September. The used mower is still at Riesterer and Schnell. No action.

The board reviewed the financial report that Treasurer Duescher presented on funding the culverts, Hidden Valley Road, Pleasant Rd culvert, tractor, mower and radios and reserve funds.
