

2025 ANNUAL TOWN MEETING

Tuesday, April 15, 2025

Daniels Town Hall at 7:00 p.m.

The 2024 Annual Town Meeting was called to order by Mike Huber. There were 11 residents in attendance. See attendance record attached. Notice posted in accordance to Wis.Stat.19.84 Open Meeting Law.

Pledge of Allegiance was recited.

Public Comments: Thank you to Town Board.

Review of the Annual Meeting Guidelines: Attendees referred to 2024 Minutes for the Annual Meeting Guidelines. **1.** The presiding officer will be the Town Chairman or appointed. **2.** Only qualified electors may vote, at least 18 years old and a resident in town for 28 days. Show of Hands chosen as voting method. **3.** Sec 60.13 of WI Stat. requires that parliamentary procedure be used. All actions of meeting shall be by vote. **4.** Only items that are listed in WI stat 60.10 can be acted on, all other items are advisory to Town Board. **5.** Actions become effective 30 days after posted. **6.** Minutes shall be prepared within 5 days of meeting and approved next year.

Motion made by Kandy Unger and seconded by Jim Kolander to nominate Mike Huber as Chairman of the meeting and to vote by raise of hands. Motion carried by show of hands, 11 in favor and 0 opposed.

2024 Year in Review of Town: Document attached. Also noted was Town Hall was paid off in September of 2024.

Approval of 2024 Annual Meeting Minutes: **Motion** made by Bob Viltz and seconded by Jim Kolander to approve the 2024 Annual Meeting minutes. Motion carried by show of hands, 11 in favor and 0 opposed.

2024 Statement of Financial Condition Report: Written copies were provided by Town Clerk Liz Simonsen. She reviewed the financial report with those present and took questions from the floor. Discussion centered around Budget concerns and debt service loans. **Motion** was made by Mike Hoefs and seconded by Bob Viltz to accept the financial report as presented. Motion carried by show of hands, 11 in favor and 0 opposed.

Long Range Road Plan: Noted was how much more it costs to maintain roads. Mike Huber reached out to the Electors for ideas of how to fund road maintenance and how much maintenance can be done yearly on limited budget. He gave a report of what roads need attention in the next 1 to 5 years. Discussion centered around how much money it would take yearly to reasonably provide safe roads. The CIP report is for 10 years and is available to taxpayers. **Motion** made by Chuck Awe and seconded by Jim Kolander to suggest the Town Board borrow monies in the range of \$300,000 to \$500,000 for road maintenance yearly. Motion carried by show of hands, 11 in favor and 0 opposed.

Oaths of Office: All 5 Town Board members took the Oath of Office in front of meeting participants.

Set date for Annual Town Meeting of 2026: No changes made from 2025. Annual Town meeting will be held on 3rd Tuesday of April per Wi Statue 60.11(2) (a). which is **Tuesday, April 21st, 2026 at 7:00 p.m.**

Any Other Business to be brought before the Town Electors: No other business.
