

Regular Town Board Meeting
Tuesday, November 11, 2025
Daniels Town Hall

Chairman Mike Huber called to order the Regular Town Board Meeting with Supervisor Mike Hoefs, Supervisor Bob Viltz, Clerk Liz Simonsen, Treasurer Kandy Unger, County Supervisor Chuck Awe, maintenance employee Jim Kolander, 3 residents and 1 non-resident present.

Pledge of Allegiance was recited.

Public Comments: Kyle Luedtke, Frederic School District, addressed the Town Board on updates of the School District, solar panel donated and sharing services with Luck School District.

Agenda: Motion made Mike Hoefs and seconded by Bob Viltz to approve the Agenda. Motion carried.

Announcements: Mike Huber commended Jim Kolander on the extra ordinary job he completed on installing culverts on Blomgren Rd, followed by round of applause.

Approval of 2026 Final Summary Budget: Motion made by Mike Huber and seconded by Mike Hoefs to approve the Final Summary Budget for 2026. Motion carried.

Chairman Report: Mike Huber is finishing the reports required for LRIP.

Burnett Co Report: Burnett Co Board had a Budget Hearing and will pass the budget at the monthly meeting. Plans for properties to be auctioned off for back taxes.

Regular Town Board Meeting: Motion made by Mike Hoefs and seconded by Bob Viltz to approve the Regular Town Board Meeting minutes of October 14, 2025. Motion carried.

Special Town Board Meeting: Motion made by Mike Huber and seconded by Bob Viltz to approve the Special Town Board Meeting minutes of October 27, 2025. Motion carried.

Treasurer's Report: Motion made by Mike Hoefs and seconded by Bob Viltz to accept the Treasurer's Report for October, 2025. Motion carried

Road Report: Maintenance on roads is wrapping up for the season. Mike Huber is finishing the WISLR report. The Town Board will start discussions for maintenance on roads for 2026.

Siren Fire Association Meeting: Meeting was on October 15th. Closed session discussions were for compensation of the Fire Chief and officers. Next meeting will be on November 19th.

Frederic Rural Fire Association Meeting: Meeting was on October 21, 2025. The Fire Chief budget was approved. \$30,000 was added to CD. The mill rate will remain the same as 2025.

Mudhen Lake Rehabilitation Meeting: Meeting was online for the Board of Commissioners on November 4, 2025. The Board worked on a meeting schedule for next year, meeting and agenda petition forms, and rules for online participation.

Cemetery Report: 2 burials for November.

Park Report: The dock and cement pads will be removed soon.

Rescind October Motion: Motion made by Mike Hoefs and seconded by Bob Viltz to rescind the motion to amend the 2025 Budget to include \$330,000 for loan proceeds in revenues and \$330,000 more in Highway Maintenance. Motion carried.

Adopt Resolution 2025-1 for G/O Loan and Debt Levy: Motion made by Mike Huber and seconded by Mike Hoefs to adopt Resolution 2025-1 to borrow \$150,000 for highway maintenance and levy the taxpayers for principal and interest. Motion carried.

Items for Future Agenda: Election Inspectors for 2026-2027.

Review of vouchers & signatures of checks: Motion made by Mike Huber and seconded by Bob Viltz to approve the vouchers 5438 through 5468 and 1029 through 1031. Motion carried.
