Regular Meeting Minutes June 10, 2025

Meeting called to order at 6:30. Chairman Lilla asked if public notice requirements were met for the meeting; Clerk Wener affirmed public notice requirements were met.

Supervisor Kujak made a motion to approve the prior month regular meeting and special meeting minutes. Seconded by Supervisor Kramer. Verbal vote, motion carried.

Road Maintenance: Chairman Lilla noted the following: mowing went well; missing signage has been replaced and additional signs will be ordered; Whistle Pass Road near Tom Lambert driveway will be leveled for roughly \$1600. Reconstruction estimate for Galewski Road was reviewed and a wedge patch option may also be considered. The town truck has blown tire and a tire with a bulge with recap tires \$375-530 per tire; Town of Trempealeau is using the \$375 tires.

Supervisor Kujak made motion to purchase four tires for the town truck. Seconded by Supervisor Kramer. Verbal vote, motion carried.

Fire Department Update: Fire Chief, TJ Fonfara, was given the floor. Chief Fonfara noted calls are steady especially first responder since the new mutual aid agreement with Buffalo County went into effect. Fonfara noted the fire department will hold a fundraiser on August 16th at the Dodge Sportsmens Club.

Review of Lottery Credit: Treasurer Tiedje shared lottery credit recipients and those not receiving credit for the board to review.

Flood Mitigation Grant: Charles Kulas was given the floor. Kulas noted the town can take over the grant from the sanitary district; start date of June 30, 2025 can be used and complete within 24 months; in kind contribution is an option for town responsibility, and town wouldn't be obligated to complete the full grant if outcome of initial stages aren't favorable.

Dodge Sanitary District: Charles Kulas was given the floor. Kulas noted the DNR annual visit will include a partial drain down.

Beverage License Hearing: License paperwork was reviewed and discussed. Supervisor Kujak made motion to accept and approve the Class B combination liquor and beer licenses for: David Harris, Judith Anderson, Stockyard's Bar and Grill LLC, Lince's Inc., and Dodge Sportsmen's Club and a Class B beer license for CSR, LLC. Seconded by Supervisor Kramer. Verbal vote. Motion carried.

Review of Orders: Orders were reviewed in the meeting. Supervisor Kujak made a motion to approve orders for payment. Seconded by Supervisor Kramer. Verbal vote. Motion carried.
