## Regular Meeting Minutes August 12, 2025

Meeting called to order at 6:30. Chairman Lilla asked if public notice requirements were met for the meeting; Clerk Wener affirmed public notice requirements were met.

Chairman Lilla noted the following: upcoming projects will be completed on bridges on Whistle Pass and Peplinski Roads; Galweski Road wedge patch will also be conducted. Concerning Dodge Hill Road dirt will be brought in and culverts checked and cleaned, if necessary. Duellman will be contacted about riprapping along the ditches/shoulder to maintain the road surface.

**Fire Department By-laws and Update:** Reviewed and discussed the by-laws. Terry Madden will be asked a few questions and by-laws reviewed by fire department. Fundraiser will be held on Saturday at the Sportsmen's Club in Dodge.

Flood Mitigation Grant: The grant was reviewed and discussed. No motion to accept the grant was made.

Chairman Lilla made motion to table the flood mitigation grant until September. Chairman Lilla rescinded the motion.

**Dodge Sanitary District:** Charles Kulas was given the floor. Kulas noted the district continues to seek bids for a pump pull and inspection.

**Trempealeau County Multi-Hazards Mitigation plan:** Every 5 years the town must review, adjust and adopt the mitigation plan. Board requested removal of curb/gutter and home elevation as projects under consideration in Dodge. Clerk Wener will contact Trempealeau County Emergency Management coordinator for the change.

**Class B Combination License Transfer:** Supervisor Kujak made motion to transfer the Class B Combo license from David E. Harris to Lil Harry RM, LLC. Seconded by Supervisor Kramer. Verbal vote. Motion carried.

**Review of Orders:** Orders were reviewed in the meeting. Supervisor Kujak made a motion to approve orders for payment. Seconded by Supervisor Kramer. Verbal vote. Motion carried.
