

## **Regular Meeting Minutes**

**September 9, 2025**

In attendance: Dan Lilla, Chairman; David Kujak, Supervisor; David Kramer, Supervisor; Kara Wener, Clerk; Becky Tiedje, Treasurer; Ken Frahm, Jr., David Frahm, Charles Kulas, Rick Kujak, Arder Maurud, TJ Fonfara

Meeting called to order at 6:30. Chairman Lilla asked if public notice requirements were met for the meeting; Clerk Wener affirmed public notice requirements were met.

Supervisor Kujak made a motion to approve the prior month regular meeting and special meeting minutes. Seconded by Supervisor Kramer. Verbal vote, motion carried.

**Public Comments:** Arder Maurud explained he would like to join the town sanitary and water district, which would mean needing to dig across the road. Supervisor Kramer recommended that he bore under the road rather than trenching across.

David Kujak noted STCSWC will accept 4 car sized or smaller tires on October 18.

**Road Maintenance:** Chairman Lilla noted the sealcoating project is set to occur next week and in preparation weeds should mowed in Schmickle Valley and weeds sprayed on Main Street. Dodge Hill Road still requires some water breaks which will handled by road worker Rick Kujak. Lilla shared that the LRIP program has undergone some significant changes double chip sealcoat projects are eligible for the program. Supervisor Kujak noted Leo Kulas Road has a shoulder issue near Heather Ziegler's home.

**Fire Department By-laws and Update:** Clerk Wener was authorized to contact legal counsel, Terry Madden concerning a few questions on the by-laws. After questions are answered, it will go to the Fire Department for review.

**Dodge Sanitary District:** Charles Kulas was given the floor. Kulas noted the new meters have been placed and all users will have the same type of meter.

**Trempealeau County Multi-Hazards Mitigation plan:** This item was tabled until the October meeting.

**Road Certification:** The road certification document was reviewed, signed and submitted in the meeting.

**Review of Orders:** Orders were reviewed in the meeting. Supervisor Kujak made a motion to approve orders for payment. Seconded by Supervisor Kramer. Verbal vote. Motion carried.

**Correspondence:** Treasurer Tiedje shared notice of CD renewal has been received. Total amount in the CD is \$72,600. Treasurer Tiedje was authorized to work FNBT to acquire the most favorable interest rate.
