

Regular Meeting Minutes

October 14, 2025

In attendance: Dan Lilla, Chairman; David Kujak, Supervisor; David Kramer, Supervisor; Kara Wener, Clerk; Ken Frahm, Jr., David Frahm, Charles Kulas, Rick Kujak, Jacob Jones and Maureen Jones

Meeting called to order at 6:30. Chairman Lilla asked if public notice requirements were met for the meeting; Clerk Wener affirmed public notice requirements were met.

Supervisor Kujak made a motion to approve the prior month regular meeting minutes. Seconded by Supervisor Kramer. Verbal vote, motion carried.

Public Comments: Fred Hoesley asked if he could hire the town to cut brush on his property. Chairman Lilla noted the town couldn't do it, but recommended a few local options.

Conditional Use Permit for N19019 County Road G: Maureen and Jacob Jones were given the floor to discuss their request for a conditional use permit. Jacob Jones shared their business plan to turn a barn on their property into an event space. Chairman Lilla noted the town has no liquor licenses available and the town has a cap on beer licenses.

Supervisor Kujak made motion to support and approve the conditional use permit for N19019 County Road G. Seconded by Supervisor Kramer. Verbal vote, motion carried. Clerk Wener was authorized to generate a letter of support for the Trempealeau County Land Use committee.

Road Maintenance and Future Road Projects: Chairman Lilla noted the following: Dodge Hill Road had rock added and was graded; bridge work for Jereczek Lane and Whistle Pass Road is scheduled; tractor had a flat tire; salt will be brought in to prep for winter; mowing will occur one more time.

The Local Road Improvement Project (LRIP) options were discussed. Possible options include milling and blacktopping Glodowski Road and a double chip sealcoat of a portion of Pine Creek Ridge Road.

Fire Department By-laws and Update: Ken Frahm was given the floor. Mr. Frahm noted the drone was used for a recent practice and the practice went well.

Dodge Sanitary District: Charles Kulas was given the floor and noted the DNR report is nearly complete.

Trempealeau County Multi-Hazards Mitigation plan: The resolution to adopt the multi-hazards mitigation plan was reviewed and the plan discussed.

Supervisor Kujak made motion to adopt the multi-hazards mitigation plan resolution. Seconded by Supervisor Kramer. Verbal vote, motion carried.

Arcadia Ambulance Board Budget: The budget was reviewed and discussed.

Chairman Lilla made motion to accept the Arcadia Ambulance Board budget for 2026. Seconded by Supervisor Kujak. Verbal vote, motion carried.

Class B Combination License Transfer: The paperwork for transferring a Class B Combination license from Judith Anderson to M and T's bar LLC was reviewed and discussed.

Supervisor Kujak made motion to approve the transfer of the Class B Combination license to M and T's bar LLC. Seconded by Supervisor Kramer. Verbal vote, motion carried.

Emergency Operation Plan (EOP): Trempealeau County Emergency Management has advised all municipalities to review and update their EOP. Clerk Wener was authorized to begin the initial work on the update and meet with necessary parties.

PASER road rating: PASER road rating will be completed by Chairman Lilla and Clerk Wener.

Set Hearing Date for the Budget Meeting: The Budget hearing and corresponding meetings will be held on Monday, November 24 at 6:30 pm.

Review of Orders: Orders were reviewed in the meeting. Supervisor Kujak made a motion to approve orders for payment. Seconded by Supervisor Kramer. Verbal vote. Motion carried.

Upcoming Meetings: The next regular meeting will be November 11 at 6:30pm.
