

Town of Doty
Monthly Board Meeting - Minutes July 8, 2025 – 7 p.m.

The Town Board meeting was called to order by Chairman Stemp at 7:00 pm in the Town Hall. Roll call was taken with Chairman Stemp, Supervisor Siewert, Supervisor Dryja, Clerk/Treasurer Field in attendance. There were (12) in attendance. The Pledge of Allegiance was said. The agenda was posted on June 26th, 2025. Clerk/Treasurer Field certifies that the open meeting law requirements have been met.

Order of the day - motion to approve agenda "order of the day", was made by Chairman Stemp, seconded by Supervisor Dryja, all were in favor.

Minutes of the Town Board Meeting from 6/10/2025, were reviewed and, Supervisor Dryja made motion, seconded by Supervisor Siewert, to approve all board minutes, all were in favor.

Acknowledgements and Updates – Supervisor Siewert thanked Tim Stephani for his help with a tree, and thanked the Road Crew for their work on Lori Lane.

Citizens Input – None.

Open bids for selling used town surplus supplies – Supervisor Siewert opened the two bids. Bid one was for Pole Saw only, \$100 from Steve Klante, the second bid was for Pole Saw \$80 and Brush Trimmer \$55 by Kevin Schneider, Steve Klante was awarded the pole saw, and Supervisor Dryja would inform Keven Schneider he was awarded the brush trimmer.

Library Report – Deb gave the update. Discussed board meeting, 2 interns for the summer, \$1200 book sale proceeds, 100 @ reading program, solar project installation would be happening with in the next week or two, 7/16 – Speaker program (Butterflies), 7/18 would be the next meeting. FUN FACT was that the Town of Doty joined the library in 2018. No motions entertained.

Road report – Supervisor Siewert gave update. Traxel Point Lane is completed, road crew has been brushing, shouldering of the roads is being done/monitored – Kevin from J&J said it should all be finished by September, grant for Eichoff Culvert is still under discussion, and tractor is still on track to be delivered at the end of July. The Utility Accommodation Ordinance (in regards to Spectrum/Fiber) was discussed – tabled to August meeting. No motions were entertained.

Cemetery report – Supervisor Dryja gave update. Not much to report, they are still trying to sell the ground penetrating equipment. No motions made.

Fire Department Report – Fire Chief Charlier was excused. Chairman Stemp gave an update (AFG/HIZ) – there were no fire calls, there was some joint training, Town of Doty may have to assist with traffic control during Mardi Gras, and Rural Insurance is going to cover the repairs needed on the tender. No motions made.

MAS – Supervisor Siewert gave updated report; (38) calls, (4) in Doty. There were (14) no transports. Supervisor Siewert reported that \$2,159.65 had been received from the Lakewood Super Valu from the round up program, FAP Funding came in at \$18,255.34, and they are still trying to sell the old ambulance. No motions entertained.

Recycling / waste report – Supervisor Dryja gave a brief update. Shrubs update, compactor discussion, property complains/led to a discussion of possible need for (was tabled) Town of Doty Public Nuisance Ordinance letter. The leak in the Oil Tank was discussed, not worth repairing and a motion was made by Chairman Stemp, seconded by Supervisor Dryja, and all were in favor to go ahead and purchase the metal tank and accessories from Laona Machining.

Humane officer report – Chairman Stemp gave update, nothing to report. No motions were entertained.

STR Report – Chairman Stemp gave update. There have been no meetings, nothing really to report, other than they are looking into how to check deeds before a permit is issued, tabled to after they have their next meeting. No motions made.

OCSO report - Supervisor Dryja gave a brief update. There has been a lot of ATV coverage. Chairman Stemp pulled up some information, (6) calls, welfare checks, traffic accident, building checks, and burglary, etc. No motions made.

Mail and Meetings – Chairman Stemp gave updates, land division had been approved, and he would be filling out the survey sheet for Bay Lakes Regional. Supervisor Dryja brought up the relaxing of RV Living requirements that are being addressed at Oconto County, the Zoning Department is not in favor, and is looking to town boards to back them up, this is tabled for further research, possibly being addressed at upcoming 7 towns meeting.

Approve Payment of Vouchers – Chairman Stemp made motion to approve, Vouchers #13039 - #13073, Federal tax payment #941072025. No Quarterly State payment was due, seconded by Supervisor Dryja, all in favor.
