

Town of Doty
Monthly Board Meeting - Minutes November 18, 2025 – 7 p.m.

The Town Board meeting was called to order by Chairman Stemp at 7:00 pm in the Town Hall. Roll call was taken with Chairman Stemp, Supervisor Siewert, Supervisor Dryja, Clerk/Treasurer Field in attendance. There were (12) in attendance. The Pledge of Allegiance was said. The agenda was posted on November 6, 2025. Clerk/Treasurer Field certifies that the open meeting law requirements have been met.

Order of the day - motion to approve agenda "order of the day", was made by Chairman Stemp, seconded by Supervisor Dryja, all were in favor.

Minutes of the Town Board Meeting from 10/14/2025, and Special Meeting from 10/28/2025, were reviewed and, Supervisor xxx made motion, seconded by Supervisor xxx, to approve all board minutes, all were in favor.

Citizens Input – None.

Approve 2026 Budget– Approve employee wages, and per diem for commissions, and committees; were all explained in detail in previous meeting. A motion was made by Supervisor Siewert to approve all, seconded by Supervisor Dryja, all were in favor.

Oconto County Camper Ordinance changes – County draft changes were discussed; all municipalities were asked to give their input. Chairman Stemp discussed the changes that Town of Doty would present to Pat Virtues. A copy of the notes will be available on November 18, no motions made.

Library Report – Update was given by Deb – solar, use of rooms, Halloween activities, grants were among the discussion points. No motions entertained.

MAS - Supervisor Siewert gave updated report; (33) calls, (9) in Doty. There were (8) no transports. DOT inspections have been completed, small leak in radiator on 2017 was repaired, so far Doty will not be charged back for the past due accounts. No motions entertained.

Cemetery report – Supervisor Dryja gave update. Not much to report. No motions made.

Fire Department Report – Fire Chief Charlier gave report. There was (2) calls. New members are working out well, (1) truck is down for repair. No motions entertained.

Humane officer report – Chairman Stemp gave update, (0) pet call in Doty. No motions were entertained.

OCSO report – Chairman Stemp gave a brief update. 26 Calls in Doty, 1 was open line 911. (Added several ordinances to bond schedule. Bond schedule will be discussed in future meetings to make penalties the same as surrounding towns where applicable). Jess is no longer the school resource officer, back at Oconto County Court. Agreement has been signed by all parties. No motions made at this time.

Road report – Supervisor Siewert gave update. (Orange snow fences, traffic speed data) were discussion topics. no motions made. Road groomer was discussed, and tabled. Grant for tractor and what is covered in the grant was also discussed. No motions entertained.

STR Report – Chairman Stemp gave update. (2) notices had gone out certified, both responding. January 2026 compliance was negotiated. No motions made.

Recycling / waste report – Supervisor Dryja gave a brief update. (Winter hours, 30 yd dumpster, dump fees, construction materials, etc, will be discussed in December). Electronics recycling needs to be picked up, Clerk/Treasurer Field will work with Recycle crew to get inventory and get scheduled. No motions.

Mail and Meetings – Chairman Stemp gave some updates, Craig Ayers visit and discussions points were among the topics. A letter regarding various changes (email addresses, website, recycling information updates, etc.) is planned to be mailed out in January 2026.

Approve Payment of Vouchers – Chairman Stemp made motion to approve, Vouchers #13208 - #13246, Federal tax payment #941112025. Quarterly State payment was not due -, seconded by Supervisor Dryja, all in favor.
