Monthly Board Meeting - Minutes April 21, 2026 – 6 p.m.

The Town Board meeting was called to order by Chairman Stemp at 6:00 pm in the Town Hall. Roll call was taken with Chairman Stemp, Supervisor Siewert, Supervisor Dryja, and Clerk/Treasurer Field being present. There were (15) in attendance. The Pledge of Allegiance was said. The agenda was posted on April 9th, 2026. Chairman Stemp certifies that the open meeting law requirements have been met.

Order of the day - motion to approve agenda "order of the day", was made by Chairman Stemp, seconded by Supervisor Dryja, all were in favor.

Minutes of the Public Hearing and Town Board Meetings from March 3/10/2026 were reviewed and, Supervisor Siewert, after making correction to change ERM to EMR made a motion to approve, seconded by Chairman Stemp to approve board minutes, all were in favor.
