**Minutes:** The minutes from June 9, 2025, Regular Board Meeting presented.

**Motion to approve June 9, 2025, Regular Board Meeting minutes (MG/TF),** all in favor, approved.

**Treasurer Report:** Dawn summarizes balance as of June 30, 2025, \$368,064.70  
Money Market funds gained \$463.99 in interest. The balance is now \$124,317.00.

**Supervisor report:** Ted – The DOT had a public meeting in June for Hwy 69 road work project set to begin in 2026. The work will start at the north edge of Monroe and head north to the New Glarus Brewery (Cow Path Lane) along with the resurfacing of two bridges. Tomorrow, there is a meeting about the Hwy 92 project from Belleville through Brooklyn to Hwy 104. There will not be total road closures, only lane closures. On June 23, sheriff called Ted to push a tree off the road after a storm. Mark – I talked with Mr. Wolf today about the property next door to the town hall (to the west). He wants \$25,000.00. Mr. Wolf believes that the lawyers should have taken care of the lien issue during his divorce. Dawn to contact the previous lawyer do a title search.

**Committee Reports:** Mark - June car show had ninety-one cars, ran out of food. There will be more food for Thursday night. A camera was placed at the park due to cars doing donuts in the park on the grass.
