Minutes: The minutes from September 8, 2025, Special Meeting were presented.

Treasurer Report: Dawn summarizes balance as of September 30, 2025, \$218,589.94. Money Market funds gained \$484.14 in interest. The balance is now \$125,703.99. **Motion to approve treasurer report (MG/KB)**, all in favor, approved.

Supervisor report: Ted – EMS meeting tomorrow night. Belleville will be contracting to New Glarus Village to provide EMS services – contract was approved at a special meeting. Brooklyn has an extra ambulance that they were planning on selling but would sell to Belleville for somewhere around \$60,000.00. Belleville will operate the ambulance out of the New Glarus Fire Station and staffed 24/7. Mark – none. Kent – none.
