The monthly meeting of the Hustisford Town Board was held on Thursday, March 6, 2025 at 7:30 pm at the Hustisford Town Hall. Treasurer Allen Hackbarth informed the Board he will have a financial report prepared before the Annual Meeting on Tuesday, April 15, 2025.

Phil Dahnert approved a \$150.00 donation for Hustisford Post Prom, Allen Hackbarth 2<sup>nd</sup>, motion carried.
