**Minutes**

The monthly meeting of the Hustisford Town Board was held on Thursday, May 1, 2025 at 7:30 pm at the Hustisford Town Hall. Present were Chairman Dave Margelofsky, Supervisor Alvin Hildebrandt, Supervisor Phil Dahnert, Treasurer Allen Hackbarth, Clerk Agnes Schultz, Ken Westphal, Nathan Dorn.

Chairman Dave Margelofsky called the meeting to order at 7:30 pm followed by the Pledge of Allegiance. There was a Quorum present.

Clerk Agnes Schultz verified the posting of the agenda at the Hustisford Town Hall, Hustisford State Bank, Husty Hardware, Hustisford Community Library and the Town of Hustisford Website.

**Public Appearance** – Ken Westphal kindly asked at the May 2025 meeting not to approve Freedom Fireworks putting up a tent again this year. Ken provided a copy of a letter from the Village of Hustisford Police making a recommendation to deny placing a fireworks tent near the intersection of STH 60 and CTH E in the Town of Hustisford.

Plan for the new parking area at the Hustisford Town Hall is still under consideration as to what to do in that area.

Phil Dahnert made a motion for Clerk Agnes Schultz to pay bills that come in after tonight's meeting (May 1, 2025) due to the meeting being on the 1<sup>st</sup> of the month, Alvin Hildebrandt 2<sup>nd</sup>, motion carried.

Phil Dahnert made a motion to approve the annual inspection of the Emergency Communication System, Alvin Hildebrandt 2<sup>nd</sup>, motion carried.

Phil Dahnert made a motion to approve Freedom Fireworks to put up a tent on N4186 County Road E, Hustisford for the 2025 season, Alvin Hildebrandt 2<sup>nd</sup>, motion carried.

Dave checked with the Dodge County Land Resources regarding the definition of subdivision and residential. Subdivision and residential according to Dodge County Land Resources is synonymous.

**Library Report** – Still in the process of replacing the Library Director. In the meantime Katelyn Stark is filling in.
