Meeting Minutes

Chairman Dave Margelofsky called the meeting to order, followed by the Pledge of Allegiance.

A quorum was present.

Phillip Dahnert made a motion to approve the November 6, 2025 Board minutes as presented, Alvin Hildebrandt seconded, motion carried.

Alvin Hildebrandt made a motion to approve the 2026 Budget and the minutes from the November 24, 2025 budget hearing, Phillip Dahnert seconded, motion carried.

Alvin Hildebrandt made a motion to accept the Treasurer's Report with \$2,755.72 in the general fund and \$65,718.33 in the NOW account, Phillip Dahnert seconded, motion carried.

Roadwork – Snow plowing season has begun. Salt/sand is used on several roads where needed.

Nate Dorn was not at the meeting to explain his intentions for his Land Use Permit.

Ross Roeseler informed the Board the Land Use Permit is to attach a sunroom to their house – **No action needed.**

Phillip Dahnert made a motion to deny the Letter of Intent for a minor land division for Jesse & Jennifer Leitzke, due to the stipulation in the certified CSM, Alvin Hildebrandt seconded, motion carried.

Rock River Working Group – 2026 Budget for the Rock River group is \$2,000. The end of 2026 is the sunset date for this project.

Alvin Hildebrandt made a motion to keep the monthly board meetings at 7:30 pm, Phillip Dahnert seconded, motion carried.

Phillip Dahnert made a motion to move the Thursday, January 1, 2026 Board meeting date to Thursday, January 8, 2026, Alvin Hildebrandt seconded, motion carried.

Allen Hackbarth reviewed the 2025 budget amendments. Phillip Dahnert made a motion to approve adjustments as discussed, Alvin Hildebrandt seconded, motion carried.

The Town received a request from Everlight Solar in November for a direct sellers permit. No action taken.

The Board will be getting a second estimate for purchasing a new chainsaw. **No action taken.**

Ross Roeseler reviewed an estimate for new flooring for the Town Hall. **No action taken.**

Phillip Dahnert made a motion to approve the following election officials for the 2026–2027 election period: Deb Whalen, Candy Graulich, Deb Ninmann, Judy Ashby, Debbie Key, Barb Margelofsky, Judy Nehls, and Amy Osmus. Phillip Dahnert seconded, motion carried.

Library Report – Not much going on currently. Jamie is doing a great job.

Recreation Report – Poms perform at home games; Santa will be at the Community Hall on December 6, 2025. Men's basketball teams are being organized; Bags league starts in January; youth basketball (grades 3–4) starts in winter.

Fire Department Report – No report.

Alvin Hildebrandt made a motion to approve paying the bills and payroll totaling \$21,192.80, Phillip Dahnert seconded, motion carried.
