Town of Lincoln Regular Meeting June 10, 2025

Chairman Bill Hassey called the meeting to order at 6:30 p.m., Pledge of Allegiance, Present: Hassey, Supervisors, Bruce Richter, Kim Simac, Ken Fox and Dick Stoegbauer, Deputy Clerk/Treasurer Sherry Schmidt and Clerk/Treasurer, Shelly Sauvola. Two other interested persons were in attendance.

Open Meeting Statement and Verification Media Notification given by Hassey. The agenda was board approved on a motion by Stoegbauer, seconded by Simac, all in favor, motion carried. The minutes from the May 13, 2025, Regular Meeting and June 3, 2025, Board of Review were approved on a motion by Simac, seconded by Richter, all in favor, motion carried. The May Treasurer's Report was provided to the Town Board. Incredible Bank general account balance, \$618,454.64 the tax savings account balance, \$10,673.12, the town hall maintenance account balance, \$83,829.83, Peoples Bank savings account balance, \$200,729.31 and Nicolet National Bank CD \$169,743.79 (current balance).

Clerk Sauvola reported that the BCPL Loan disbursement was received for 2025 roadwork expense. Sauvola also reported that the CD at Nicolet National Bank has been renewed for a 6-month period at a 4% rate, the maturity date will be right about the time the new fire truck for the Joint Municipal Fire Department is set to be delivered. Approximately \$108,000 will be funded from the CD, the board will apply for an additional loan from the BCPL for \$100,000, to cover the Lincoln share of the cost of the purchase. Chairman Hassey reported that the Barrish Road and Oneil Road projects (shared with the Town of Three Lakes) were completed and reported that Pitlik & Wick has agreed to separate the roadwork bill between Lincoln and Cloverland for the Boot Lake Road shared project. Sauvola reported that the board of review training materials were available for Supervisors Simac and Stoegbauer, and Chairman Hassey whenever they want to complete the training. Sauvola also reported that all the supporting documents and requested materials have been submitted to the Wisconsin Disaster Fund for the grant funding request from the wind/ice storm on March 28, 2025. If the grant is approved, Lincoln would be responsible for 30% of the total \$27,000 price tag for cleanup and the grant would cover the remaining 70%. Supervisor Fox and Hassey reported that they have reached out to American Transmission Co. and Wisconsin Public Service to see if the town could possibly get help with a culvert project in the Adams Road and County Highway G area seen as they both have lines buried at the location.

A motion was made by Simac to approve the following list of Alcohol Beverage License Applications contingent that the license fees have been paid, there are no holds on the license due to outstanding liquor bills and any delinquent real estate taxes owed to Vilas County must be satisfied before the license is issued, motion seconded by Fox, all in favor, motion carried.

The board authorized two members of the Town Board (Chairman and one Supervisor, if the Chairman is absent, two Supervisors) to approve a variance request to reduce the setback from town road right of ways in certain instances, eliminating the full board approval needed at a regularly scheduled meeting of the town board. The motion was made by Stoegbauer, seconded by Richter, all in favor, motion carried.

The board approved the payment of bills, vouchers #18180 through #18213.

Motion to adjourn made by Stoegbauer, seconded by Fox, all in favor, motion carried. The meeting was adjourned at 6:56 p.m.
