Town of Lincoln Regular Meeting August 12, 2025

Chairman Bill Hassey called the meeting to order at 6:30 p.m., Pledge of Allegiance, Present: Hassey, Supervisors; Bruce Richter, Kim Simac, Ken Fox, and Dick Stoegbauer, Deputy Clerk/Treasurer Sherry Schmidt and Clerk/Treasurer, Shelly Sauvola. Four other interested persons were in attendance.

Open Meeting Statement and Verification Media Notification given by Hassey. The agenda was board approved on a motion by Stoegbauer, seconded by Simac, all in favor, motion carried. The minutes from the July 8, 2025, Regular Meeting and July 21, 2025, Special Meeting were approved on a motion by Stoegbauer, seconded by Richter, all in favor, motion carried. The July Treasurer's Report was provided to the Town Board. Incredible Bank general account balance, \$453,432.04, the tax savings account balance, \$10,673.66, the town hall maintenance account balance, \$85,858.87, the Peoples Bank savings account balance, \$202,027.62, and Nicolet National Bank CD \$169,743.79 (current balance).

Deputy Clerk/Treasurer Sherry Schmidt provided an update on her progress with her education at the UW Green Bay's Clerks and Treasurers Institute. She has earned her certification through the Clerk's Institute. Schmidt will complete her schooling next year, earning her Treasurer Completion certification, and with that will be on track to earn the additional designation of a Wisconsin Certified Municipal Clerk. Schmidt thanked the board for supporting her attendance. Schmidt also reported that the Focus on Energy project has been completed, and the application requesting incentive bonus dollars for the project has been submitted. A reminder was given that the upcoming Board of Review is scheduled for Tuesday, August 19th, beginning at 10:00 a.m. Chairman Hassey reported that a meeting was held with himself, Supervisor Fox, and City of Eagle River Mayor Debbie Brown. There continues to be an ongoing problem with people abusing the rules at the brush site on Elm Drive that is shared with the City of Eagle River. A new gate is currently being installed to hopefully help keep violators out. Supervisor Fox gave an update on the Landfill. Chairman Hassey reported that the Braywood Lane/Boat Landing area needs some road maintenance. There has been an issue with higher water amounts flowing towards the restaurant, and concerns that the rising water level will begin going into the building. Kevin Ludwig will further investigate the issue.

Approval to make application for a loan from the Board of Commissioners of Public Lands, Trust Funds of the State of Wisconsin, for \$108,000.00 (payable within 2 years) to help finance the Lincoln share (estimated \$207,936.00), Joint Municipal Fire Department purchase of a new ladder truck was made on a motion from Simac, seconded by Stoegbauer, all in favor, motion carried.

Resolution 2025-02, Borrow Funds From the BCPL State of Wisconsin Trust Funds and Levy Tax was adopted on a motion by Stoegbauer, seconded by Richter, Simac aye, Stoegbauer aye, Hassey aye, Fox aye, Richter aye, all in favor, motion carried.

The board discussed an ETF Resolution (2025-03) for Inclusion Under the Wisconsin Public Employers' Group Health Insurance Program. The board was provided with information on the program, options, and costs. Currently, there are two town employees, the Clerk/Treasurer and Deputy Clerk/Treasurer, who are eligible to participate in the program. A motion was made by Simac to move forward with participation, seconded by Stoegbauer; all in favor, motion carried. A special meeting of the town board will be scheduled soon to approve the resolution and select from the program options.

A Temporary Alcohol Beverage License (picnic license) for Humane Society of Vilas County at 1100 US Hwy 45 for September 7, 2025, Pet Days of Summer Event was approved on a motion by Stoegbauer, seconded by Richter, all in favor, motion carried.

The board discussed the Animal Control Officer Vacancy due to the resignation of Melissa McDonald on July 31st. The board is intending to pursue other options at this point.

The board approved the payment of bills, vouchers #18234 through #18271.

Motion to adjourn made by Richter, seconded by Fox, all in favor, motion carried. The meeting was adjourned at 7:13 p.m.
