

**Town of Lincoln
Regular Meeting
December 9, 2025**

Chairman Hassey called the meeting to order at 6:30 p.m., Pledge of Allegiance, Present: Hassey, Supervisors; Ken Fox, Kim Simac, Bruce Richter, and Dick Stoegbauer, and Clerk/Treasurer Shelly Sauvola. Six other interested persons were in attendance.

Open Meeting Statement and Verification Media Notification given by Hassey. The agenda was board-approved on a motion by Fox, seconded by Stoegbauer, all in favor, motion carried. The minutes from December 1, 2025, Budget Hearing, Special Town Elector Meeting, and Special Town Board Meeting, and November 11, 2025, Regular Meeting were approved on a motion by Stoegbauer, seconded by Richter, all in favor, motion carried. The November Treasurer's Report was provided to the Town Board. Incredible Bank general account balance, \$540,512.30, the tax savings account balance, \$10,674.71, the town hall maintenance account balance, \$87,553.50, the Peoples Bank savings account balance, \$204,626.29, and the Nicolet National Bank CD \$173,343.69 (current balance).

Supervisor Fox provided an update on the LRIP County Town Road Improvement Committee Meeting that was held on December 5th.

Operator License Applications for Amy Jo McCormick and Jennifer R. Larson were approved on a motion by Richter, seconded by Simac, all were in favor, and the motion carried.


The board approved line-item amendments to the 2025 Budget. A motion was made by Richter approving the transfer of \$35,765 from Road Repair and Maintenance (53307), with \$6,000 going to Town Board (51100), \$6,765 to Brushing and Mowing (53310), \$23,000 to Road Signs and Markings (53311), the motion was seconded by Stoegbauer, all were in favor, and the motion carried.

Election Inspectors for the 2026-2027 term were approved on a motion by Simac, Republican Party; Lois Parnitzke, Tom Nitz, Karen Hassey, Alexis Appleberry, and Carol Teschky, Democratic Party; Barb Leveille, Laurie Stoegbauer, Joe Panci, Nan Andrews, and Steve Sparks, Unaffiliated; Norman and Lynette Spiess, Scott Kolinski, Marlys Scharf, Mary Hayden, Marita Levine and Sherry Schmidt (Deputy Town Clerk), motion seconded by Fox, all in favor, motion carried.

The board approved hourly wages for poll workers in the 2026-2027 term, with Election Inspectors receiving \$14.00 and Chief Inspectors receiving \$17.00, on a motion by Richter, seconded by Stoegbauer; all were in favor, and the motion carried.

The board approved the payment of bills, vouchers #18381 through #18412.

Motion to adjourn made by Richter, seconded by Fox, all were in favor, and the motion carried. The meeting was adjourned at 6:45 p.m.
