

**MINUTES OF THE TOWN OF MERRILL BOARD MEETING
HELD AT THE TOWN OF MERRILL COMMUNITY CENTER
NOVEMBER 10TH, 2025 IMMEDIATELY FOLLOWING THE SPECIAL
MEETING OF ELECTORS AND PUBLIC BUDGET HEARING**

ROAD REPORT

Chairman Tony Baumann reported that spray patching has been completed.

American Asphalt is going to be paving the intersection of Highway K and Lake Pesobic Road, along with the intersection of Hillside and Lake Pesobic, and repairing Duginski Road where the culvert was replaced.

EQUIPMENT REPORT

Chairman Tony Baumann reported that we needed to order new parts for the sander on the Western Star, and they have been delivered.
