1. The meeting was called order at 10:01 AM.
2. Rollcall Peggy White, Darryl Darby, Nanette Mone and Valerie Bird present
3. State recording status Nanette Mone
4. Follow up ethics commissions recommendations regarding Nanette's recusal. Conversation with Amy Nye at the ethics commission reported there was no reason for recusal. Nanette spoke both to Kim Leach and Terry and she clarified that she thought she had to refuse if she knew somebody involved but actually she had no links to anything financial that would influence her decision regarding this matter.
5. Meeting minutes for March 13 and March 19 board of health meetings were reviewed. A motion was made, seconded and all in favor
6. HEALTH INSPECTOR's report: Eagle eye Institute does not fall into the regulations for a camp. The inspectors at the Berkshire Public Health alliance met and discuss this matter. The institute is currently looking for counselors. The plan is to inspect and to check if they are a nonprofit or not. No further information on 32 North Rd. They are doing some work. There is still no active driveway cut and they need a culvert. Conservation commission recommended a full culvert and Highway Dept to require a sign off on the permit. Plan for Dan does biweekly visits. Garnet Lake will plan to test the water before Memorial Day and before July 4 and the end of August. Colleen O'Claire at 36 South Rd. extension. Val will send a letter and permit application and request pumping records. 20 South Rd. extension needs a perk test and will keep a close eye on that property. Bruce Cullett on Curtin Road is putting in a septic which will eventually be able to accommodate a four bedroom house but currently is planned to just be used for an RV.
7. Val is looking into the tax status of 55 East Windsor Rd.
8. The March governing board meeting was reviewed with updates.
9. The public hearing for the well regulations a scheduled and will be posted for 5/21/24 at 5:30 PM. The public notice will be sent to the Berkshire Eagle on 4/30/24 to be posted 5/6/24. An agenda will be generated and posted in the usual places as well. At the completion of the hearing a copy of the Public notice of the actual newspaper must be sent to the DEP as well as copies of improvement and a copy of the regulation. This packet will be given to Terry the town administrator. The agenda for the meeting will be discussed Well regulations and the title will be Peru board of health public hearing for while regulation.
10. Discussion of the fee schedule will be postponed until a future meeting.
11. There will also be a 5/28/24 board of health meeting to discuss the input and vote on the well regulations. The June Board of Health meeting will be on June 10, 2024.
