1. Call to Order at 7:30pm. Dale Judd was present. Alex Elkins joined by telephone. Dave Garfoot and Vic Wahl were also present.
2. Reading and approval of Board minutes of September 9th, 2024. Tabled until next month.
3. Treasurer's report and approval of bills. Alex moved to approve the treasurer's report. Dale seconded. Motion carried 2-0.
4. Public comments: Only agenda items may have action taken. There were none.
5. Malcom Austin: Discussion and possible action regarding the New Glarus Fire District 2025 budget. Malcom presented the new fire budget for 2025. He explained that it has recently been updated so that they can capitalize the cost of new radios. The new budget adds \$2955.30 to Primrose's portion for each of four years. This fund expires in 2028.

Dale made motion to approve the proposed budget with the radio funding as stated. Alex seconded. Motion passed 2-0.

6. Steve Salerno: Presentation regarding the Mount Horeb Area School District Referendum.

Dr. Salerno presented the proposed 2024 referendum for the Mount Horeb Area School District. The referendum would fund removal of the existing Early Learning Center (kindergarten) and its' replacement with an addition to the existing main building. It would also fund the renovation of the main building for

- handicap accessibility
- adding two indoor basketball courts
