Whereas, the Wisconsin state legislature has encouraged fiscal restraint by establishing tax levy limits on municipal budgets, providing needed tax relief to property owners;

Whereas, the Town of Primrose has proposed an operating budget for 2025 that heeded that direction and significantly restrained expenditures without reducing services;

Whereas, substantial cutbacks in other revenues have significantly restricted the Town of Primrose's ability to pay for essential local services;

Whereas, Wis. Stat. § 66.0602(3)(f) permits municipalities to use a portion of the prior year's unused tax levy limit, up to a maximum of 1.5% of the actual tax levy;

RESOLUTION OF TOWN BOARD PROPOSING TO EXCEED LEVY LIMIT

Town of Primrose, Dane County

Resolution No. 2024 - 03

Whereas, the State of Wisconsin has imposed levy limits on town, village, city, and county levies for 2024 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602 limits the allowable local levy for 2024 to a percentage increase of no more than the <u>greater</u> of (a) zero percent of the 2023 payable 2024 adjusted actual levy as calculated under the state's levy limit law or (b) a percentage equal to the percent change in equalized value due to net new construction less improvements removed, which for the <u>Town of Primrose</u> is <u>0.235%</u>;

Whereas, the town board of the <u>Town of Primrose</u>, <u>Dane County</u>, believes that for the 2024 tax levy (to be collected in 2025) it is in the town's best interest to exceed the state levy limit as described above by a greater percentage than <u>0.235%</u>;

Whereas, the <u>Town of Primrose</u>'s 2023 payable 2024 adjusted actual tax levy was <u>\$288,133</u>, and further whereas the state law would limit this year's increase to <u>\$288,810</u>, for a total allowable town tax levy after adjustments for 2024 (to be collected in 2025) of <u>\$329,428</u>;

THEREFORE, the town board of the Town of Primrose, Dane County, does hereby resolve and order as follows:

- 1. The town board supports an increase in the town tax levy for 2024 that will exceed the amount allowed by the state levy limit.
- 2. The town board directs that the question of increasing the allowable town tax levy for 2024 (to be collected in 2025) by <u>.91%</u>, which would increase the town levy by <u>\$3,000</u> for a total tax levy (after adjustments) of <u>\$332,428</u> shall be placed on the agenda for the special town meeting to be held on November 7, 2024.
