5. James Stansfield: Discussion and possible action regarding agricultural development on Parcel 0507-211-9070-9.

Mr. Stansfield explained that he wants to farm this parcel and wants to be sure he can access it and farm it before making an offer on it.

Martha explained that access is limited but seems possible. The Dane County Highway and Transportation is aware of the parcel and should be contacted regarding a field road (farm drive was opposed to a residential drive).
