**Annual Town Audit 2024 Results – Amber Drewieske (CLA):** Ms. Drewieske handed out copies of annual audit report. There were no findings to report.

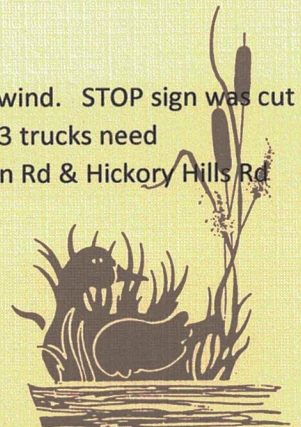
