**Town of Rockland December 8, 2025 Board Meeting**  
**Rockland Town Hall @ 7:00 P.M.**

Chairperson Rosalie Geiger called the meeting to order at 7:00 p.m. opening with Pledge of Allegiance. Officials present were Rosalie Geiger, Derek Genske, Mike Havlinek, Daniel Benter, Deputy Clerk; Laurie Miller and road superintendent; Keith Brandes. There were three visitors present. Motion made by Mike Havlinek and seconded by Derek Genske to approve the secretary's report as posted and printed. Motion carried. Motion made by Derek Genske to accept the Treasurer's Report as read, seconded by Mike Havlinek. Motion carried.

**The agenda was followed as printed and posted.**

**Public Input:** Chairperson Geiger was again contacted by a citizen requesting the Board change their ordinance for no golf carts on town roads. It was determined there will be no changes to the ordinance currently in effect.

**Reports and Communications:** WISLR report was completed and submitted. Town will be receiving refund of taxes charged from QuickBooks. Received correspondence from Ayres Associates on recommended maintenance for 6-20' structures, plan will be reviewed under Road Superintendent Report.

**License & Permits:** Razing permit issued to William Matznick, 102 Rockea Rd, Chilton; removing 15x55 silo. No building permits were issued.

**Town Building Inspector Contract 2026-2028:** Scott Beining sent updated contract for the 2026-2028 calendar years. Mike Havlinek made a motion to accept the contract, seconded by Derek Genske. Motion carried. Chairperson Geiger signed the new contract.

**Medical Insurance for Town Employee:** Derek Genske made a motion to pay \$1,000 per month towards health insurance premium of town employee upon retirement from his current job. Mike Havlinek seconded the motion. Motion carried. Clerks will look into the best option to handle the reimbursement.

**Resolution 2025-12-08 Appointing Election Inspectors for 2026-2027 Cycle:** As a follow-up to November town board meeting appointing election inspectors, there were no persons who submitted affiliated paperwork, therefore Mike Havlinek made a motion to file resolution, seconded by Derek Genske. Motion carried. Chairperson Geiger signed Resolution 2025-12-08 appointing the election inspectors as previously listed.

**Resolution 2025-12-08.1 Authorizing Town Clerk to Designate Election Inspectors Numbers, Shifts & Alternates:** Mike Havlinek made a motion to authorize Town Clerk to determine number of election inspectors and shifts needed for each election. Derek Genske seconded. Motion carried with 3 yes votes and 0 no votes. Chairperson Geiger signed Resolution 2025-12-08.1

**Road Superintendent Report on Roads/Culverts/Signs:** Truck #43 had plow ram repaired & a radiator has been ordered for it. Truck #41 blew a front tire so new tires will be needed & brake chamber. Red plow truck the spinner does not work so Keith will take to his shop to try to get it operational. Town did hire one new plow driver and will continue to look for more interest. Received a load of sand from Madsen, however it was screened later in the season and is not really suitable to use as it does freeze. Ayres Associates report of bridge on Hilltop Rd is in need of repair as there are wide cracks and it is shifting. Road Superintendent will contact Manitowoc County to discuss replacing with box culvert and look into costs.


**Constable Report:** Nothing to report.
